**Move ups** for the trial must be received by 6 p.m. on Monday, July 2.

Parking is available close to the building.

Crating/setup: The building will be open at 8:00 a.m. for set-up. There is no set-up on Sunday evening.

From Harrisburg: 15 South to Steinwehr Avenue Exit. Turn right off ramp onto business 15 North. Event site is located 3 miles on the right.

**From Washington DC (Frederick)**: 270 to 15 North to Steinwehr Avenue Exit. Turn left off ramp onto business 15 North. Event site is located 3 miles on the right.

**From Philadelphia**: PA Turnpike West to exit 236 (Gettysburg Exit). 15 South to Steinwehr Avenue Exit. Turn right off ramp onto business 15 North. Event site is located 3 miles on the right.

**From Pittsburgh**: PA Turnpike West to exit 201 (Blue Mt Exit). 997 South to 30 East will come to circle in Gettysburg. Bear to the right and take business 15 South. Event site is located 5 miles south of town on the left.

**From Lancaster (York)**: 30 West to 15 South. Take Steinwehr exit. Right off ramp onto business 15 North. Event site is located 3 mile on the right.

**From Baltimore (Westminster)**: 695 to 795 to 140 West to 15 North. Take Steinwehr Avenue Exit. Turn left off ramp onto business 15 north. Event site is located 3 miles on the right.

From New York City: 80 West to 81 South to 83 South to 581 West to 15 South. Take Steinwehr Avenue Exit. Turn right off ramp onto business 15 North. Event site is located 3 miles on the right.

**From Hagerstown**: 81 North to Waynesboro exit. 16 East to 15 North to Steinwehr Avenue Exit. Turn left off ramp onto business 15 North. Event site is located 3 miles on the right.

At the traffic circle, take the 2nd exit onto Carlisle St., 0.5 miles. Turn right at E Broadway/US-15 BUS N, 0.2 mile. Turn left at Harrisburg St/US-15 BUS N. Continue to follow US-15 BUS N, Destination will be on the left. Total distance: 6.7 miles / Total travel estimate: 14 minutes
