Crating/Parking Information:

Exhibitors may set up in the building at 7:00 a.m. on Monday morning. There is plenty of crating space. There is plenty of parking available near the building.

***Please note: Event is in ALLSTAR EVENTS COMPLEX to the right of the hotel, not in the hotel itself.**

From Harrisburg & North: Route 15 South to Steinwehr Avenue Exit. Turn right off ramp onto Business 15 North to site 3 miles on the right.

From Washington DC and South: Route 270 to Route 15 North to Steinwehr Avenue Exit. Turn left off ramp onto Business 15 North to site 3 miles on the right

From Philadelphia and Southern New Jersey: PA Turnpike (Rt 76) to Exit 17 (Gettysburg).
Route 15 South to Steinwehr Avenue Exit. Turn right off ramp onto Business 15 North to site 3 miles on the right.

From Pittsburgh and West: PA Turnpike (Rt 76) to Exit 15 (Blue Mountain Exit). Route 997 South to Route 30 East. Follow Route 30 East to Gettysburg. From the traffic circle in Gettysburg, bear to the right and take Business Route 15 South to site 5 miles on the left.

From Lancaster/York PA: Route 30 West to Route 15 South to Steinwehr Avenue Exit. Turn right off ramp onto Business 15 North to site 3 miles on the right.

From New York City and Northern New Jersey: Route 78 West to Route 81 South. Route 81 South to Route 83 South to Route 581 West. From Route 581 West, take Route 15 South to Steinwehr Avenue Exit. Turn right off ramp onto Business 15 North to site 3 miles on the right.

Located approximately 4 miles south of downtown Gettysburg on US Business Route 15 South. Exit from 15 Bypass at Steinwehr Avenue Exit and travel north 2 miles.
