## World of Pets Expo Information

- Entry in the Farm Dog Certification **does not** entitle you to free entry into the World of Pets Expo. You will need to purchase tickets each day. <u>Ticket information is located HERE</u>.
- Parking at the fairgrounds is free. There is no reserved parking for this event. Please note and respect any
  signage that may be present. Parking is tight on Saturday and Sunday, so arriving later in the day may mean a
  long walk to the building.
- Hours of operation:
  - o Saturday: 10:00 AM to 7:00 PM
  - Sunday 10:00 AM to 5:00 PM
- No exhibitors will be allowed in the Pet Expo vendor area when the Pet Expo is not open to the public

### Notice to Exhibitors

- Location: We will be located in the same part of the building as the Agility Trial, along the wall behind the bleachers.
- Running order: Due to varying schedules, activity level at the event, and other factors, there are no set times for
  any dog to be tested, other than within the trial times listed below. We will have a signup sheet at the site for
  exhibitors to select the approximate time they wish to test. Testing takes approximately eight minutes. Otherwise,
  we will take people as they come.
- AM Testing will run from 9:00 AM until 1:00 PM. We ask that any exhibitor who is already in the building as a vendor or an agility exhibitor to please plan on testing before the Expo opens. We might even start earlier if we can get everything set up.
- PM Testing will run from 1:00 PM to 5:00 PM each day.
- It is the exhibitor's responsibility to be tested within the time periods listed above.

## Day of Show Entries

- We will accept day of show entries up until the stated limits have been reached.

#### Directions to the Trial Site

The Maryland State Fairgrounds in Timonium is located just north of Baltimore and is easily accessible from I-83 (Exit 17).

- From Baltimore: Follow I-695 (Baltimore Beltway) to I-83 North (Exit 24). North on I-83 approximately 2 miles to Exit 17 (Padonia Rd). Follow signs to Fairgrounds approximately 1.5 miles.
- From the North: I-83 to Exit 17 (Padonia Rd). Follow signs to Fairgrounds approximately 1.5 miles.
