## **Armband Numbers / Check-In:**

Armbands will be available at the check-in table (alphabetical by owner). Gate sheets will be available for check-in **only**. Any changes in running order must be done by the Gate Steward for the class.

**Check-in for Measuring:** Begins each day at 7:00 a.m. Additional measuring time will be provided (as available) as courses are being set. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. We will have a measuring official at the trial. There will be a VMO (Rhonda Crane) available at the trial each day. **Reminder:** All exhibitors should carry their dog's original AKC official Jump Height Card with them to each trial, in order to present the card, should they be asked, upon request.

**Move ups** for the April 6 trial must be received by 6 p.m. on Monday, April 2. Move-ups for Friday-Saturday or Saturday-Sunday will be allowed and must be submitted within ½ hour of the end of judging each day. The move-up book will be located on the check-in table. Just fill out your move-up form and leave it in the book. Magically, your move-up will happen overnight. ☺

**Parking** is located close to the building. No RV's or ex-pens will be allowed in the parking area. No overnight parking at the show site. Please do not block the driveway. Additional parking is available at the new office building on the left of the driveway.

**Crating/setup:** Setup will be available on Thursday evening from 7 – 9 p.m. for those who help unload the truck and set up the rings and equipment. Waterproof cloth or tarps must be placed underneath crates. The building will be open on Friday, Saturday and Sunday mornings at 6:30 a.m.

**Food and refreshments** will be available at the trial site.

**We wish to thank all those who have volunteered to help at this trial.** The worker coordinator will be Shellie Goldstein. Any and all assistance makes for a smoother running trial, so please check with her often to see how you can help! Workers coupons will be good for \$2 towards lunch at the site, future agility entries, for use as "vendor bucks" or donated to the charity fund-raiser. Enjoy and thanks for volunteering!

From **Baltimore:** From Baltimore Beltway (I-695) take Exit 19, Northwest Expressway (I-795) towards Owings Mills/Reisterstown. Continue until the Expressway ends, bear right onto Route 140 West. Follow 140 West for approx. 10 miles, turn left onto Route 97 (Weis Market on right, PetSmart market on the left.) At the 2<sup>nd</sup> light, turn Left onto Old Westminster Pike. The Carroll Indoor Sports Center will be on the right a short distance after the turn.

From **DC & Virginia:** From DC Beltway (I-495) take I-270 exit towards Frederick. From 270, take Damascus exit (Route 27 North). Stay on 27 North approx. 25 miles to Main Street in Westminster. Turn right onto Main Street. Go 1.5 miles. C.I.S.C. will be on right side of road after crossing over Route 97.
