## Check-in:

Your check-in will be at the gate sheets and are for check-in *only*. Any changes in running order must be done by the Gate Steward for the class.

Check-in for Measuring: Begins at 8:00 a.m. on Friday, 7:00 a.m. on Saturday and Sunday. Additional measuring time will be provided (as available) as courses are being set. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. We expect to have a measuring official at the trial. This means that all dogs that do not have a temporary or permanent measurement will need to be measured prior to running. Reminder: All exhibitors should carry their dog's original AKC official Jump Height Card with them to each trial, in order to present the card if requested.

Move ups for the April 5 trial must be received by 6 p.m. on Monday, April 1. Move-ups for Friday-Saturday or Saturday-Sunday will be allowed and must be submitted within $1 / 2$ hour of the end of judging each day. The move-up book will be located on the check-in table. Just fill out your move-up form and leave it in the book. Magically, your move-up will happen overnight. ©

Parking: See parking instructions on next page.
Crating/setup: The rings will be available for crating on Friday morning immediately after equipment and ring gating has been "unloaded" except for those willing to help with ring set-up. (Time is approximately 7:30 AM on Friday, 7:00 AM on Saturday). NO SET-UPS or site accessibility on Thursday evening. Water ONLY in the crating area, please.

Crating space in the ring area is limited, so plan on getting cozy with your neighbor and sharing where you can. High occupancy ex-pens only ( 3 dogs or more) on the fields. There is limited crating space upstairs (the "big" field upstairs is no longer available.)

The terms of the facility contract make it necessary for us to completely clear BOTH RINGS after the end of the Friday trial (ONLY) for other scheduled events on Friday evening. ALL crates, chairs, etc. must be removed from the fields (only). FISC typically provides an area for us to store "stuff" overnight, and we will have more information at the trial. We will not have to clear either ring after the Saturday trial.

Food and refreshments will be available at the trial site. P.I.G.S. is still our wonderful food vendor, and the menu looks great!

## Parking - Special Instructions

The parking map below clearly outlines available parking. Do not park in the parking areas of the businesses directly across from the Sports Center. You WILL be towed.

Some parking places in front of the building are reserved for FISC employees and tenants. The facility will post signs at these places, so please look for them and avoid these spots.

The parking map below clearly outlines available parking. The facility marks spaces that are used for their tenants and employees, so please be sure to respect those signs. The spaces marked "Reserved for exhibitors working from their cars" (this map is used year-round) may be used for that purpose ONLY if the weather permits. (Preliminary running order contingent on move-ups not yet received.)
Walk-Throughs:
Friday: Exc/Master Standard and JWW will have separate walk-throughs for the 4/8, 12, 16, 20/24/24C height divisions (4 walks).
Saturday/Sunday: Exc/Master Standard and JWW will have separate walk-throughs for the 4/8, 12, 16, 20 \& 24/24C height divisions (5 walks).

## All three days:

Novice STD, Open STD, Novice JWW, Open JWW, Premier STD, Premier JWW \& Time2Beat: One walk-through per class.

> Novice/Open FAST is a combined course with one walk-through each day.
> Exc/Master FAST will have a split walkthrough - 2 walkthroughs and will walk/walk/run/run).

Additional walk-throughs at the discretion of the judge.
Lunch break to be taken at Judge's discretion.
