### Check-in:

Your check-in will be at the gate sheets and are for check-in \*only\*. Any changes in running order must be done by the Gate Steward for the class.

**Check-in for measuring:** Begins on Friday at 7:30 a.m., Saturday and Sunday at 7:00 a.m. Additional measuring time will be provided (as available) as courses are being set. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. We WILL have a VMO present at the trial. Reminder: All exhibitors should carry their dog's original AKC official Jump Height Card with them to each trial and should present the card upon request.

**Move ups** for the July 19 trial must be received by 6 p.m. on Monday, July 15 (no exceptions). Move-ups for Friday-Saturday or Saturday-Sunday will be allowed and must be submitted within ½ hour of the end of judging each day. The move-up book will be located on the check-in table. Just fill out your move-up form and leave it in the book. Magically, your move-up will happen overnight. ☺

**Directions:** The **Frederick Indoor Sports Center** is located at 1845 Brookfield Ct., Frederick, MD 21701. From Route 70, merge onto US-40 toward US-15 N/Gettysburg (US-40 becomes US-15 N). Merge onto MD-26 E/Liberty Rd. via Exit 17 toward MD-194/Libertytown/Walkersville. Take the 1<sup>st</sup> right onto Routzahns Way/MD-355. Take 1<sup>st</sup> right onto Wormans Mill Ct. Take the 1<sup>st</sup> left onto Brookfield Ct. FISC is on the right.

**Food and refreshments** will be available at the trial site. P.I.G.S. BBQ is the on-site restaurant, and the menu looks great! Note: The restaurant opens at 11:00 AM, so breakfast will not be available. **Crating/setup:** The building will be open to agility exhibitors each day at 6:30 a.m. Please note that although the doors are sometimes open earlier for other activities in the building, the club needs to complete ring and equipment set-up before exhibitors will be allowed on the field. NO SET-UPS or site accessibility on Thursday evening. Water ONLY in the crating area, please.

**We will be required to COMPLETELY CLEAR the ring at the end of the Friday trial for another scheduled event. Items will need to be completely removed (including all mats, crates, chairs, etc.) by 6:00 PM. We will not have to clear the ring on Saturday. FISC is making an area available for overnight storage. It is upstairs just past the bleachers on the side of the building we are using. There is a gate closing off the upstairs field on "our" side, and items can be stacked all the way up to the gate since it's not being used as a way in/out of the upstairs field. Yes, you can use the elevator to get your stuff up there – the dire warning sign on the elevator is not meant for adults. ☺**

Crating space on the field is limited. The space on the right wall as you enter the ring is reserved for trial committee. Crates will have priority. Please plan to get cozy with your neighbor and share where you can. If there is insufficient space, you will be asked to remove chairs from the crating area. No tables on the field floor unless they are over crates. There is additional crating upstairs. **The Event Committee may limit or move an exhibitor's crating area if it is in the best interests of the trial.**

Saving of spots on the field will not be allowed. You are welcome to put down a tarp for your friend upstairs.

**We wish to thank all those who have volunteered to help at this trial.** Any and all assistance makes for a smoother running trial, so please check with the volunteer coordinator often to see how you can help! Volunteers will receive a coupon for each class worked that can be used for future entries or at the P.I.G.S. Restaurant located inside the facility. **Volunteering just got easier!** The Volunteer sheet will be posted at the trial site each day. You can go in and fill in your name where you'd like to work, with our thanks!

# Parking - Special Instructions

**FRIDAY ONLY: \*ALL\* parking places directly in front of the building are reserved for FISC employees and tenants. See special parking map below.**

**SATURDAY & SUNDAY: A few parking spaces immediately in front of the building will be reserved for FISC employees and tenants. Everything else is fair game! 😊**

The parking map below clearly outlines available parking. The facility posts signs where dog show parking is not allowed, so please look for them and avoid these spots.

**NEW: There is a large new gravel lot to the left of the building.**

Unloading: You may unload at the front entrances. There is also access to the building from the side.

**Do not park in the parking areas of the businesses directly across from the Sports Center. You WILL be towed.**

There are marked 1-hour parking spaces directly in front of the building. We have been told they will tow any vehicle parked for more than 1 hour in the marked 1-hour parking places.

**Motorhome Parking:** Parking for motorhomes is available at the show site (in the larger of the two areas marked "Event Parking"). No reservation is required. Your cooperation is appreciated. **Sometimes, there is a locked gate at the entrance to the Parking Area. The combination is available at the front desk of FISC, and they are normally open until 11:00 PM.**
