● COVID-19 “Stuff” – Policies, Restrictions and Whatnot:

As of July 1, the State of Maryland has lifted most covid-19 mask wear and occupancy restrictions. Businesses can set their own rules on mask wearing.

IMPORTANT:

If you are exhibiting signs of illness or have been otherwise told to self-quarantine due to known COVID-19 exposure, please stay home.

For the July 23-25 agility trials, the restrictions have been eased to include the following:

- Crating will be allowed inside the building.
- The mask policy is **MASKS OFF** inside the building for all those fully vaccinated. Please come prepared to present your vaccination card (original vaccination card, a photocopy of the card, a digital photo of the card). You will receive a nifty bracelet in exchange for flashing your card. 😊
- A written COVID waiver will not be required.

Leashes: You may run with your leash in your pocket (must fit fully) or wear them while running the course. Don't drop it!

Course maps: Paper course maps will not be available. Course maps will be posted on the website of the trial secretary (www.clantyre.net) after approximately 9:00 PM each evening, sent to exhibitors via email and available on Agility Gate. One copy will be posted if you did not receive them another way. Come prepared to photograph the map for personal use.

Briefings/walkthroughs: See judging schedule page for briefing/walkthrough schedule. Briefings are not required for Excellent/Master classes. Because of the reduced walkthrough sizes, each group should expect the walk to last no more than 5-7 minutes.

Check-in – We will be using the Agility Gate App! **THE TRIAL CODE IS: 0373**

- Download the Agility Gate app, which is available on the Apple iOS App Store and on Google Play for Android. You will need an internet connection to install and use the app.
- After you launch the app, you'll be presented with a screen. Press the button in the top left corner that looks like three horizontal lines to choose the club/event you want to follow.
- Find the class you want to follow, click on it to open the running order for that particular class.
- You will be asked for the code for the trial. You should only need to do this once. **The trial code is: 0373**
- After picking a class, you will be presented with the running order for the class you chose. Running order is broken up by height and only displays the information for the specific class that you are watching.
- If you place your finger on a row in the running order and swipe towards the left, you'll reveal four buttons that you can use to update your dog's status: Check-in, Scratch, FEO or Conflict. Pick the option that best matches your dog's status. You can always swipe to the left to reveal the buttons again and change your dog's status later.
- The running order will update automatically as dogs are checked in, when they run, etc. Keep an eye on the running order to see when you are due up.
- You should be at the building ready to run 6 dogs before your turn.

● **And now, the REGULAR “Stuff”!**

Check-in for measuring: Begins on Friday at 4:00 PM and Saturday/Sunday at 7:15 AM and available throughout the day as courses are being set. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. A Measuring Official will be present at this trial. All dogs without height cards (including those jumping 24" & 24C") will need to be measured. Reminder: All exhibitors should carry their dog's original AKC official Jump Height Card with them to each trial.

Crating/setup: The trial site will be open at 4:00 PM on Friday, 6:45 AM each trial day on Saturday and Sunday.

Flooring Restrictions:

A waterproof pad is required under all crates. Only WATER is allowed on the turf flooring—no other type of beverage. Crumbly dog treats are not allowed on the turf flooring. Soft dog treats are allowed. Food, gum and drinks other than water will not be allowed on the field turf flooring. Please exercise your dog often. If there is an accident, there is a charge of \$5 to offset the cost of cleaning of the turf.

Food will not be available at the trial site. Please plan on packing your lunch. Fast food is available nearby.

Parking: There is plenty of parking near the building. Please follow any signage that may be present.

Limited daytime RV Parking is available. No electric, no hookup. Contact Rhonda Toren (agilitysec@clantyre.net) for additional information.

Move ups for the July 23 trial must be received by 6 PM on Monday, July 19. Move-ups Saturday-Sunday will be allowed and must be submitted within ½ hour of the end of judging each day. (To make your Trial Secretary happier, you can move up as soon as you get done celebrating your new title rather than leaving it to the end of the day.) 😊 The move-up book will be located near the Trial Secretary. Look for it around the table with the score monitors.

Directions to the trial site:

From 95 North: Take Exit 50A-50B onto Caton Ave toward South Washington. Keep right onto Caton Ave S toward Washington Blvd. Turn right onto Joh Ave. Turn left onto Benson Ave. Turn left onto Knecht Ave. Turn left onto Azar Ct, #9 is on the right.

From Interstate 695/Baltimore Beltway: Take Exit 11A-11B for Interstate 95 South towards Washington. Keep right and follow signs for Sulphur Springs Rd. Turn right onto Sulphur Springs Rd (signs say Arbutus/Violetville). Take the first right onto Benson Ave. Take a right onto Knecht Ave. Turn left onto Azar Ct, #9 is on the right.

As always, exhibitors are responsible for cleaning up any deposits left by their dog.

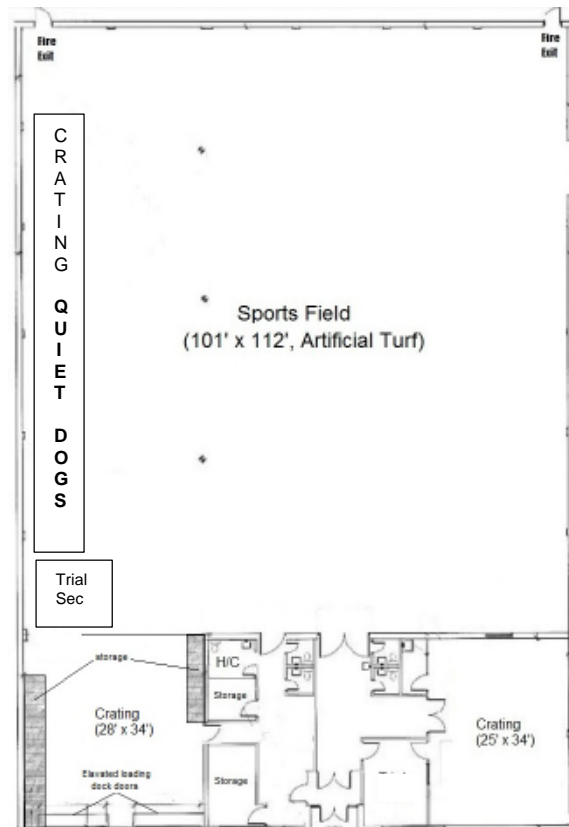

Crating & Facility Information

We ask that exhibitors be considerate of others regarding crating space. There are a number of rooms in the front part of the building which will be marked as crating areas. There is limited crating next to the ring, which can be used if the dog in the crate is well-behaved. Crating space is extremely limited, so plan on getting cozy with your neighbor and sharing where you can. Crates have priority. Ex-pens are allowed but must contain 3 or more dogs. If there is insufficient space, you will be asked to remove chairs from the crating area. Due to space limitations, unentered dogs may be asked to leave.

The Event Committee may limit or move an exhibitor’s crating area if it is in the best interests of the trial.
