Armband Numbers and Check-In: Armbands will be available at the check-in table (alphabetical by owner).

<u>Check-in for measuring</u>: Begins on Friday at 8:15 a.m., Saturday and Sunday at 7:15 a.m. Additional measuring time will be provided (as available) as courses are being set. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. **Reminder**: All exhibitors should carry their dog's original AKC official Jump Height Card with them to each trial, in order to present the card upon request. **VMOs** will be present all three days. If you do not have a permanent height card, your dog MUST be measured for one.

<u>Move ups</u> for the July 31st trial must be received by 6 p.m. on Monday, July 27. Day-to-day move-ups will be allowed and must be submitted within ½ hour of the end of judging each day. The move-up book will be located on the check-in table. Just fill out your move-up form and leave it in the book. Magically, your move-up will happen overnight. ©



SITE INFORMATION



IMPORTANT NOTES:

There are plenty of access doors for dogs through the rear, left side and front of the building.

Crating/setup: We will be unloading equipment beginning at 6:00 p.m. on Thursday for those who wish to help.

The building will open at 8:00 a.m. on Friday for set-up.

There will be NO access to the building prior to 8:00 a.m. for dogs OR people (except for trial officials/committee.)

Crate aggressive/reactive dogs must be covered and may not be positioned on the corners of aisles or entrances to the crating areas. This will be strictly enforced. If complaints are received, dogs will be moved. NO Flexi-leads are allowed indoors.

<u>Chairs ONLY (no crates!) in the Standard and JWW rings</u>. Crating areas will be in other field turf rings not used for competition. Please crate in marked areas only. All crates, ex-pens, etc. set up anywhere on field turf MUST have protective barrier underneath.

<u>Dogs will NOT be allowed</u> in the front row of seating closest to the ring gating or within 5 feet of the ring gating unless they are getting ready to enter the ring.

No food or drinks on playing field. (This rule has been relaxed for our agility trials. However, utmost care of the turf is a priority at all times.) No glass containers, chewing tobacco, chewing gum, sunflower seeds or similar products permitted in the facility.

Do **not** approach the field house staff regarding the indoor temperature.

Food and refreshments will be available at the trial site. Dogs will not be allowed in the area in front of the food vendor!

REMEMBER! KEEP THE AREA CLEAN! As always, exhibitors are responsible for cleaning up any deposits left by their dog. Do NOT allow dogs to eliminate on the shrubs anywhere against the building.

Any exhibitor failing to follow these rules will be EXCUSED without benefit of refund if the Show Committee deems the exhibitor is in violation of this requirement. Let's keep this beautiful site dog friendly!
