General Information: The Arena is heated for the comfort of the dogs, so bring a jacket or sweater. Indoor bathrooms and a food vendor will be available.

Crating/setup: The Arena will be open at 6:45 AM each trial day.

Exhibitors who will help with unloading/ring setup may set up on Thursday starting at 5 PM. They may place a marker for their personal setup areas before helping, and can complete their setup areas when the unloading and basic ring setups are completed. Exhibitors not helping with unloading may set up on Thursday only between 6:30 pm and 7:15 PM, at which time the building will be closed.

We ask that exhibitors be considerate of others regarding crating space. Crating space is limited, so plan on getting cozy with your neighbor and sharing where you can. Due to space limitations, unentered dogs may be asked to leave. The Event Committee may limit or move an exhibitor's crating area if it is in the best interests of the trial.

Parking: Parking attendants will be onsite each day to direct you to a parking place. Failure to follow the parking attendants' directions is a misconduct offense and will not be tolerated. NO STOPPING immediately in front of the building.

Check-In/Course maps: Check-in will be at the gate sheets that will be located at ringside. Course maps will be available at the information table near the Secretary area.

Check-in for measuring: Begins each day at 7:00 AM and available throughout the day. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. **VMOs** will present at this trial, so all dogs without height cards (including those jumping 24" & 26") will need to be measured. Reminder: All exhibitors should carry their dog's original AKC official Jump Height Card with them to each trial, in order to present the card, should they be asked, upon request.

Move ups for the December 9 trial must be received by 6 PM on Monday, December 5. Move-ups for Friday-Saturday or Saturday-Sunday will be allowed and must be submitted within ½ hour of the end of judging each day. **Your trial secretary will be happiest if you fill out your move-up form as soon as you get done celebrating your title rather than waiting until the end of the day.** ☺ The move-up book will be located on the check-in table. Just fill out your move-up form and leave it in the book. Magically, your move-up will happen overnight. ☺

Directions to the trial site:

From the North, East, or South: Follow I-695 (Baltimore Beltway) to Exit 19 (I-795) towards Owings Mills/Reisterstown continuing until the expressway ends. Bear right onto Route 140 West (towards Westminster) continuing for 10.9 miles to the light at Center Street. Turn left at the light onto Center Street. Proceed 1.6 miles through a four-way stop sign and two traffic lights. Go past the Farm Museum on the right and Carroll Hospital on the left and you will be at the stop sign at Gist Road. Turn right onto Gist Road. Drive 0.1 miles to new entrance and turn right onto new Ag Center drive.

From the East or South - Alternate route (more back road driving): Take Route 32 West (to Sykesville/Westminster). Turn left on Kate Wagner Road. Turn right onto Gist Road. After you pass Smith Ave turn left at new entrance (on left) onto new Ag Center drive.

From the West:

From I-70 Exit 68 – Route 27 North to right onto Kate Wagner Rd. Turn left onto Gist Road and follow alternate route directions above.

From I-70 Exit 76 – Route 97 North to left on Hook Road. Turn right onto Gist Road and follow alternate route directions above.

From I-70 Exit 80 – Route 32 West. Left onto Kate Wagner Rd. Right onto Gist Road and follow alternate route directions above.

***WALK-THROUGH SCHEDULE:**

Exc/Master Standard and JWW will have separate walk-throughs for the 4/8, 12, 16, 20* & 24/26 height divisions.

**Exc/Master Standard and JWW 20" walkthroughs will be split (walk/walk/run/run) all 3 days.*

Time2Beat and Exc/Master FAST will be broken into 4/8/12/16 & 20/24/26.

All other classes (Novice/Open STD, JWW & FAST, Premier Standard & Premier JWW): One walk-through for all heights.

Lunch Break to be taken at Judge's discretion.

IMPORTANT:

Please be on the line at least 4 dogs before your turn.

Handlers with multiple dogs: Please request to walk with an EARLIER height group other than the one your dog is entered in if a conflict is imminent. This insures timely results for each height.

If you find that your dogs are too close in the running order, don't panic! Just ask the judge or ring steward to help you move your dog(s) appropriately on the gate sheet.

Dogs will not be permitted within 10 feet of the ring gating or in the front row of seating next to the rings. Please be considerate of other participants. Thanks! ☺
