<u>Check-in/Course maps</u>: Check-in will be at the gate sheets that will be located on the walls near each ring. Course maps will be available at the information table near the front entrance.

<u>Check-in for measuring</u>: Begins each day at 7:00 AM and available throughout the day. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. Both judges are **VMOs**, so all dogs without height cards (including those jumping 24" & 24C") will need to be measured. Reminder: All exhibitors should carry their dog's original AKC official Jump Height Card with them to each trial, in order to present the card, should they be asked, upon request.

<u>Move ups</u> for the December 7 trial must be received by 6 p.m. on Monday, December 3. Move-ups for Friday-Saturday or Saturday-Sunday will be allowed and must be submitted within ½ hour of the end of judging each day. The move-up book will be located on the information table. Just fill out your move-up form and leave it in the book. Magically, your move-up will happen overnight. ©

<u>Crating/setup</u>: For you early birds! Equipment will need to be unloaded from the MAD trailer on Friday morning for this trial, and will begin at 6:00 AM. Those that help with the unloading will be given priority for set-up. They may place a marker for their personal setup areas before helping, and can complete their setup areas when the unloading and basic ring setups are completed. Exhibitors not helping with unloading may set up on Friday morning starting no earlier than 6:45 AM (strictly enforced). NO SET-UPS or site accessibility on Thursday evening. Water ONLY in the crating area, please.

This is a FULL trial. We ask that exhibitors be considerate of others regarding crating space. Crating space is limited, so plan on getting cozy with your neighbor and sharing where you can. Due to space limitations, unentered dogs may be asked to leave. The Event Committee may limit or move an exhibitor's crating area if it is in the best interests of the trial. There is additional crating space upstairs, but the large upstairs field will not be available.

The building will be open to exhibitors on Saturday and Sunday at 6:30 AM.

Oriole Dog Training Club has rented both rings for Friday night. This means that we will NOT have to clear the rings! (Hooray!!)

Food and refreshments will be available at the trial site. P.I.G.S. is still our wonderful food vendor, and the menu looks great!

## **Parking - Special Instructions**


The parking map below clearly outlines available parking. Do not park in the parking areas of the businesses directly across from the Sports Center. You WILL be towed.

Some parking places in front of the building are reserved for FISC employees and tenants. The facility will post signs at these places, so please look for them and avoid these spots.

The parking map below clearly outlines available parking. The facility marks spaces that are used for their tenants and employees, so please be sure to respect those signs. The spaces marked "Reserved for exhibitors working from their cars" (this map is used year-round) may be used for that purpose ONLY if the weather permits. They will not be policed; it's an "honor system" style of parking. ©

Unloading: You may unload at the front entrances. There is also access to the building from the side.

<u>Motorhome Parking:</u> Parking for motorhomes is available at the show site (in the area marked "Overflow Parking"). No reservation is required. Your cooperation is appreciated. *Sometimes, there is a locked gate at the entrance to the Overflow Parking Area. The combination is available at the front desk of FISC, and they are normally open until 11:00 PM.*

One walk-through for all heights in the following classes:

Time2Beat, Novice and Open STD & JWW, Premier Standard & Premier JWW

Novice & Open FAST may be a combined course. If so, there will be one combined Novice/Open walk-through. Exc/Master FAST will have a split walk-thorough (walk/walk/run/run): Friday/4-16, 20-24C, Sat/Sun/24C-20, 16-4

Lunch Break to be taken at Judge's discretion.

#### **IMPORTANT:**

Please be on the line at least 4 dogs before your turn.

<u>Handlers with multiple dogs</u>: Please request to walk with an EARLIER height group other than the one your dog is entered in if a conflict is imminent. This insures timely results for each height.

If you find that your dogs are too close in the running order, don't panic! Just ask the judge or ring steward to help you move your dog(s) appropriately on the gate sheet.

Dogs will not be permitted within 10 feet of the ring gating or in the front row of seating next to the rings. Please be considerate of other participants. Thanks! ©
