Check-in/Course maps: Check-in will be at the gate sheets that will be located on the walls near each ring. Course maps will be available at the information table near the front entrance.

Check-in for measuring: Begins each day at 7:00 AM and available throughout the day. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. We do not expect a Measuring Official at the trial. All dogs without temporary or permanent height cards will need to be measured by the judge prior to running. This measurement will be valid for this weekend of trials only. Reminder: All exhibitors should carry their dog's original AKC official Jump Height Card with them to each trial, in order to present the card, should they be asked, upon request.

Move ups for the December 6 trial must be received by 6 p.m. on Monday, December 2. Move-ups for Friday-Saturday or Saturday-Sunday will be allowed and must be submitted within ½ hour of the end of judging each day. The move-up book will be located on the information table. Just fill out your move-up form and leave it in the book. Magically, your move-up will happen overnight. ☺

Parking: See parking instructions on next page.

Crating/setup: For you early birds! Equipment will need to be unloaded from the MAD trailer on Friday morning for this trial, and will begin at 6:00 AM. Those that help with the unloading will be given priority for set-up. They may place a marker for their personal setup areas before helping, and can complete their setup areas when the unloading and basic ring setups are completed. Exhibitors not helping with unloading may set up on Friday morning starting no earlier than 6:45 AM (strictly enforced). NO SET-UPS or site accessibility on Thursday evening. Water ONLY in the crating area, please.

This is a FULL trial. We ask that exhibitors be considerate of others regarding crating space. Crating space is limited, so plan on getting cozy with your neighbor and sharing where you can. Due to space limitations, unentered dogs may be asked to leave. The Event Committee may limit or move an exhibitor's crating area if it is in the best interests of the trial. **There is additional crating space upstairs, but the large upstairs field will not be available.**

The building will be open to exhibitors on Saturday and Sunday at 6:30 AM.

Oriole Dog Training Club has rented both rings for Friday night. This means that we will NOT have to clear the rings! (Hooray!!)

Food and refreshments will be available at the trial site. P.I.G.S. is still our wonderful food vendor, and the menu looks great!

From Route 70, merge onto US-40 toward US-15 N/Gettysburg (US-40 becomes US-15 N). Merge onto MD-26 E/Liberty Rd. via Exit 17 toward MD-194/Libertytown/Walkersville. Take the 1st right onto Routzahns Way/MD-355. Take 1st right onto Wormans Mill Ct. Take the 1st left onto Brookfield Ct. FISC is on the right.

Parking - Special Instructions

RED SPACES: Parking spaces indicated in red are reserved for FISC employees and tenants. See parking map.

YELLOW SPACES: Some spaces are designated for handicapped parking. The rest can be used by exhibitors working from their car (weather permitting). They will not be policed, it's an "honor system" style of parking. 😊

BLUE SPACES: Judges, chair, secretary. Park there at your own risk. 😊

The parking map clearly outlines available parking. The facility posts signs where dog show parking is not allowed, so please look for them and avoid these spots.

NEW: There is a large new gravel lot to the left of the building.

Unloading: You may unload at the front entrances. There is also access to the building from the side.

Do not park in the parking areas of the businesses directly across from the Sports Center. You WILL be towed.

There are marked 1-hour parking spaces directly in front of the building. We have been told they will tow any vehicle parked for more than 1 hour in the marked 1-hour parking places.

Motorhome Parking: Parking for motorhomes is available at the show site (in the larger of the two areas marked "Event Parking"). No reservation is required. Your cooperation is appreciated. ***Sometimes, there is a locked gate at the entrance to the Parking Area. The combination is available at the front desk of FISC, and they are normally open until 11:00 PM.***



Volunteers!

Any and all assistance makes for a smoother running trial, so please check with the volunteer coordinator in each ring often to see how you can help! **Volunteering just got easier!** The Volunteer boards will be posted for each ring at the trial site each day. While the use of flexi-leads is not prohibited on show grounds, we urge you to use them responsibly. Failure to properly control a dog at an event can be grounds for a misconduct hearing. WALK-THROUGH SCHEDULE

Exc/Master Standard and JWW will have separate walk-throughs for the 4/8, 12, 16, 20 & 24/24C height divisions.

One walk-through for all heights in the following classes:

Novice FAST and Open FAST is a combined course and there will be one combined walk-through.

Exc/Master FAST will have a split walk-through (walk/walk/run/run): Fri/Sun: 4-16, 20-24C Sat: 24C-20, 16-4

IMPORTANT

Please be on the line at least 4 dogs before your turn.

Handlers with multiple dogs: Please request to walk with an EARLIER height group other than the one your dog is entered in if a conflict is imminent. This insures timely results for each height.

If you find that your dogs are too close in the running order, don't panic! Just ask the judge or ring steward to help you move your dog(s) appropriately on the gate sheet.

Dogs will not be permitted within 10 feet of the ring gating or in the front row of seating next to the rings.
