### **Armband Numbers / Check-In:**

Armbands will be available at the check-in table (alphabetical by owner). Gate sheets will be available for check-in only. Any changes in running order must be done by the Gate Steward for the class.

**Check-in for measuring:** Begins each day at 7:00 AM and available throughout the day. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. A Measuring Official will be present at this trial. All dogs without height cards (including those jumping 24" & 26") will need to be measured. Reminder: All exhibitors should carry their dog's original AKC official Jump Height Card with them to each trial, in order to present the card, should they be asked, upon request.

As always, exhibitors are responsible for cleaning up any deposits left by their dog. Any exhibitor failing to pick up after their dog will be EXCUSED without benefit of refund if the Event Committee deems the exhibitor is in violation of this requirement.

**Crating/setup:** The trial site will be open at 6:45 AM each trial day.

We ask that exhibitors be considerate of others regarding crating space. There are a number of rooms in the front part of the building which will be marked as crating areas. High occupancy ex-pens (3 dogs or more) only will be allowed in the front rooms. There is limited crating next to the ring, which can be used if the dog using the crate is well-behaved. Crating space is extremely limited, so plan on getting cozy with your neighbor and sharing where you can. Crates have priority. If there is insufficient space, you will be asked to remove chairs from the crating area. Due to space limitations, unentered dogs may be asked to leave. **The Event Committee may limit or move an exhibitor's crating area if it is in the best interests of the trial.**

### **Flooring Restrictions:**

A waterproof pad is required under all crates. Only WATER is allowed on the turf flooring—no other type of beverage.

Crumbly dog treats are not allowed on the turf flooring. Soft dog treats are allowed. Food, gum and drinks other than water will not be allowed on the field turf flooring. Please exercise your dog often. If there is an accident, there is a charge of \$5 to offset the cost of cleaning of the turf.

**Food will not be available at the show site. Please plan on packing your lunch. Fast food is available nearby.**

**Parking:** There is plenty of parking near the building. There will be a few extra marked Handicapped slots available, first-come, first-served. The cross-hatched "loading dock" spaces closest to the front door of the building may be used for those working out of their cars for ONLY if the weather permits. They will not be policed; it's an "honor system" style of parking. ☺

Limited daytime RV Parking is available. No electric, no hookup. Contact Rachael Toren ([clantyre@gmail.com](mailto:clantyre@gmail.com)) for additional information.

**Move ups** for the June 11 trial must be received by 6 PM on Monday, June 6. Move-ups Saturday-Sunday will be allowed and must be submitted within ½ hour of the end of judging each day. The move-up book will be located on the check-in table.

### **Directions to the trial site:**

**From 95 North:** Take Exit 50A-50B onto Caton Ave toward South Washington. Keep right onto Caton Ave S toward Washington Blvd. Turn right onto Joh Ave. Turn left onto Benson Ave. Turn left onto Knecht Ave. Turn left onto Azar Ct, #9 is on the right.

**From Interstate 695/Baltimore Beltway:** Take Exit 11A-11B for Interstate 95 South towards Washington. Keep right and follow signs for Sulphur Springs Rd. Turn right onto Sulphur Springs Rd (signs say Arbutus/Violetville). Take the first right onto Benson Ave. Take a right onto Knecht Ave. Turn left onto Azar Ct, #9 is on the right.

# “Potty” Instructions



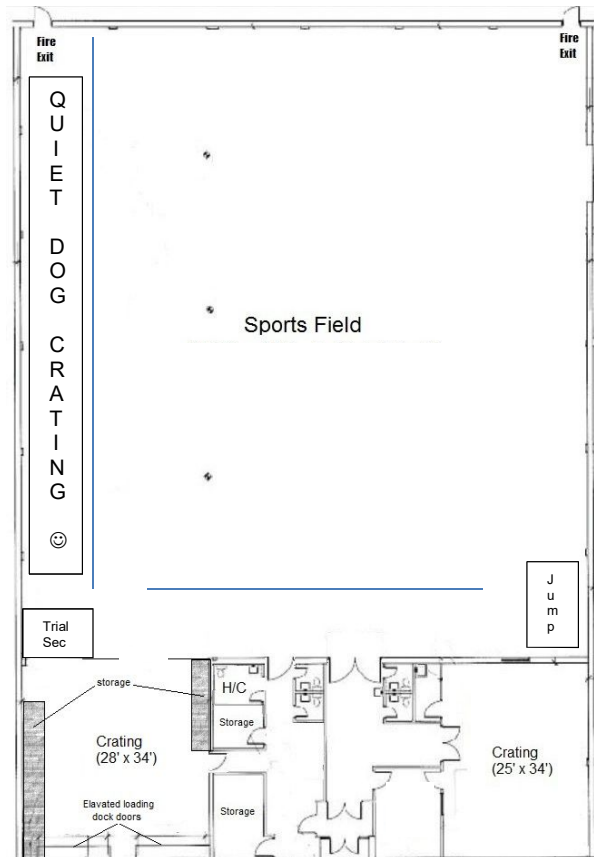
**As always, exhibitors are responsible for cleaning up any deposits left by their dog.**

# Crating & Facility Information

We ask that exhibitors be considerate of others regarding crating space. There are a number of rooms in the front part of the building which will be marked as crating areas. High occupancy ex-pens (3 dogs or more) only will be allowed in the front rooms. There is limited crating next to the ring, which can be used if the dog using the crate is well-behaved. Crating space is extremely limited, so plan on getting cozy with your neighbor and sharing where you can. Crates have priority. ## Judging Schedule

**The first official briefing and walk-through will begin each day 8:00 AM.**

Exc/Master Standard and JWW will have 2 walk-throughs: 4/8/12", 16/20/24/26"

Novice, Open and Premier Standard & JWW, Time2Beat and all FAST classes will have 1 walk-through per class.

Lunch Break to be taken at Judge's discretion.
