Check-in:

Your check-in will be at the gate sheets and are for check-in *only*. Any changes in running order must be done by the Gate Steward for the class.

<u>Check-in for measuring</u>: Begins each day at 7:00 AM and available throughout the day. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. A Measuring Official will be present at this trial. All dogs without height cards (including those jumping 24" & 24C") will need to be measured. Reminder: All exhibitors should carry their dog's original AKC official Jump Height Card with them to each trial.

As always, exhibitors are responsible for cleaning up any deposits left by their dog. Any exhibitor failing to pick up after their dog will be EXCUSED without benefit of refund if the Event Committee deems the exhibitor is in violation of this requirement.

Crating/setup: The trial site will be open at 6:45 AM each trial day.

Flooring Restrictions

A waterproof pad is required under all crates. Only WATER is allowed on the turf flooring—no other type of beverage.

Crumbly dog treats are not allowed on the turf flooring. Soft dog treats are allowed. Food, gum and drinks other than water will not be allowed on the field turf flooring. Please exercise your dog often. If there is an accident, there is a charge of \$5 to offset the cost of cleaning of the turf.

Food will not be available at the trial site. Please plan on packing your lunch. Fast food is available nearby.

Parking: There is plenty of parking near the building. Please follow any signage that may be present.

Limited daytime RV Parking is available. No electric, no hookup. Contact Rachael Toren (clantyre@gmail.com) for additional information.

Move ups for the June 8 trial must be received by 6 PM on Monday, June 4. Move-ups Saturday-Sunday will be allowed and must be submitted within ½ hour of the end of judging each day. (To make your Trial Secretary happier, you can move up as soon as you get done celebrating your new title rather than leaving it to the end of the day.) ③ The move-up book will be located on the check-in table.

Directions to the trial site:

From 95 North: Take Exit 50A-50B onto Caton Ave toward South Washington. Keep right onto Caton Ave S toward Washington Blvd. Turn right onto Joh Ave. Turn left onto Benson Ave. Turn left onto Knecht Ave. Turn left onto Azar Ct, #9 is on the right.

From Interstate 695/Baltimore Beltway: Take Exit 11A-11B for Interstate 95 South towards Washington. Keep right and follow signs for Sulphur Springs Rd. Turn right onto Sulphur Springs Rd (signs say Arbutus/Violetville). Take the first right onto Benson Ave. Take a right onto Knecht Ave. Turn left onto Azar Ct, #9 is on the right.

As always, exhibitors are responsible for cleaning up any deposits left by their dog.




Any exhibitor using areas marked as "DO NOT POTTY" and/or failing to pick up after their dog will be EXCUSED without benefit of refund if the Event Committee deems the exhibitor is in violation of this requirement.

Crating & Facility Information

We ask that exhibitors be considerate of others regarding crating space. There are a number of rooms in the front part of the building which will be marked as crating areas. There is limited crating next to the ring, which can be used if the dog in the crate is well-behaved. Crating space is extremely <u>limited</u>, so plan on getting cozy with your neighbor and sharing where you can. Crates have priority. Ex-pens are allowed but must contain 3 or more dogs. If there is insufficient space, you will be asked to remove chairs from the crating area. Due to space limitations, unentered dogs may be asked to leave.

The Event Committee may limit or move an exhibitor's crating area if it is in the best interests of the trial.

UNOCCUPIED TARPS WILL BE REMOVED AT 10:00 AM ON SATURDAY. ("Saving space" for those not in attendance will not be allowed.)



Judging Schedule

Running Order as of May 29, 2019

Preliminary judging schedule contingent upon move-ups and wait-listed entries that have not yet been processed.

This is a one-ring trial. The first official briefing and walk-through will begin each day 7:45 AM (First dog on the line at 8:00 AM.)

Exc/Master Standard and JWW will have 2 walk-throughs: 4/8/12", 16/20/24/24C" (walk/run/walk/run)
Novice, Open and Premier Standard & JWW, Time2Beat will have 1 walk-through per class
FAST is a combined course and will have 2 walk-throughs: 4/8/12/16", 20/24/24C" (walk/walk/run/run)

Lunch Break to be taken at Judge's discretion.
