Armband Numbers / Check-In:

Armbands will be available at the check-in table (alphabetical by owner). Gate sheets will be available for check-in **only**. Any changes in running order must be done by the Gate Steward for the class.

Check-in for measuring: Begins both days at 7:00 a.m. Additional measuring time will be provided (as available) as courses are being set. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. **Reminder:** All exhibitors should carry their dog's original AKC official Jump Height Card with them to each trial, in order to present the card upon request.

Move ups for the July 28 trial must be received by 6 p.m. on Monday, July 23. Day-to-day move ups will be allowed between trial days and must be submitted in person to the trial secretary within ½ hour of the end of judging on Saturday. The move-up book will be located on the check-in table. Just fill out your move-up form and leave it in the book. Magically, your move-up will happen overnight. ☺

Parking is located close to the building. Please do NOT block the driveway. You may unload at the front entrances. There is also access to the building from the side. There is also a circular paved "overflow" parking area to the right of the building.

RVs that do not fit completely within the confines of a regular 7 x 18 parking space are strictly prohibited. **No ex-pens** in the parking area. There is no overnight parking at the site.

Food and refreshments will be available at the trial site.

Crating/setup: The building will be available on Saturday immediately after all equipment is unloaded on Saturday (approximately 7:00 a.m.), and at 6:45 a.m. on Sunday morning. NO SET-UPS or site accessibility on Friday evening. Matting **MUST** be used under your crates. Water **ONLY** in the crating area, please.

This is a full trial, and crating space is limited, so plan on getting cozy with your neighbor and sharing where you can. There is additional crating space upstairs. Due to space limitations, unentered dogs may be asked to leave.

Directions: The **Frederick Indoor Sports Center** is located at 1845 Brookfield Ct., Frederick, MD 21701.

From Route 70, merge onto US-40 toward US-15 N/Gettysburg (US-40 becomes US-15 N). Merge onto MD-26 E/Liberty Rd. via Exit 17 toward MD-194/Libertytown/Walkersville. Take the 1st right onto Routzahns Way/MD-355. Take 1st right onto Wormans Mill Ct. Take the 1st left onto Brookfield Ct. FISC is on the right.

Turn right from the FISC onto Wormans Mill Ct. Turn left onto N. Market St./MD-355. Continue to follow MD-355. Take 1st left onto MD-26 W/Liberty Rd. Merge onto US-15 S toward Frederick. Take the US-15 S/US-340 W exit toward Leesburg/Charles Town. Take the Jefferson St. exit on the left. Merge onto S. Jefferson St. Turn right onto Prospect Blvd. The Animal Hospital is on the right. Total travel distance: 4.9 miles, approximately 8 minutes.
