Armband Numbers / Check-In:

Armbands will be available at the check-in table (alphabetical <u>by owner</u>). Gate sheets will be available for check-in *only*. Any changes in running order must be done by the Gate Steward for the class.

<u>Check-in for measuring</u>: Begins both days at 7:00 a.m. Additional measuring time will be provided (as available) as courses are being set. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. **VMO's** will be available both days for permanent measurements. **Reminder:** All exhibitors should carry their dog's original AKC official Jump Height Card with them to each trial, in order to present the card upon request.

<u>Move ups</u> for the July 26 trial must be received by 6 p.m. on Monday, July 21. Day-to-day move ups will be allowed between trial days and must be submitted in person to the trial secretary within ½ hour of the end of judging on Saturday. The move-up book will be located on the check-in table. Just fill out your move-up form and leave it in the book. Magically, your move-up will happen overnight. ©

<u>Parking</u> is located close to the building. Please do NOT block the driveway. You may unload at the front entrances. There is also access to the building from the side. There is also a circular paved "overflow" parking area to the right of the building.

Motorhome parking (reservation required) is in the "overflow" parking area ONLY. No ex-pens in the parking area.

Food and refreshments will be available at the trial site.

<u>Crating/setup</u>: The building will be available on Saturday immediately after all equipment is unloaded on Saturday (approximately 7:00 a.m.), and at 6:45 a.m. on Sunday morning. NO SET-UPS or site accessibility on Friday evening. Water ONLY in the crating area, please.

This is a full trial, and crating space is limited, so plan on getting cozy with your neighbor and sharing where you can. There is additional crating space upstairs. Due to space limitations, unentered dogs may be asked to leave.

As always, exhibitors are responsible for cleaning up any deposits left by their dog. We want to keep this beautiful site dog-friendly!


Parking - Special Instructions
