The exhibitor is fully responsible for entering the dog in the correct class(es)/height divisions. Dogs running in a lower height division than they are eligible for will be eliminated

## **Measuring and Height Card Information**

Exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured/wicketed by the Judge of Record PRIOR to running in their class and this measurement will be valid for that weekend of trials only. The exception to this requirement is a dog entered in the 24" or 24C" height division. However, if a Volunteer Measuring Official (VMO) or an Agility Field Rep is present; ALL dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog before its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

Jump Height Card Process: When filling out the entry form, there is a box on the form for exhibitors to designate whether their dog needs to be officially measured. Please indicate (by checking the box) if your dog needs to be on the Dogs To Be Measured List. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during day of show check-in.

## **Dogs Eligible to Enter**

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/ Indefinite Listing Privileges (PAL/ILP), or approved Foundation Stock Service (FSS) breeds are eligible to participate. Entries are open to All-American/Mixed Breed dogs listed in the AKC Canine Partners program. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes.

## **Obstacles and Ring Conditions**

Obstacles shall meet the specifications for obstacles in the current edition of Regulations for Agility Trials and are supplied by the Shetland Sheepdog Club of Greater Baltimore. Electronic timers will be used.

All classes will take place outdoors on grass. Ring size will be 100 x 100.

## **Course Walk-throughs and Warm-Up Information**

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent. Please make every effort to walk with an "earlier" group to insure the smooth running of the trial and timely results for each height division.

A warm-up area, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

## **Ribbons, Awards and Prizes**

Ribbons will be awarded in each jump height in each class as follows:  
First Place.....Blue  
Second Place.....Red  
Third Place.....Yellow  
Fourth Place.....White  
Qualifying Score.....Dark Green Ribbon

A rosette will be offered to all dog/handler teams finishing a title.

## **Move-Up Information**

Per Chapter 1, Section 20, American Kennel Club Regulation for Agility Trials: Dogs shall be moved up to a higher class at the request of the owner, as a result of qualifying for an agility title, provided that the request is made in writing to the Trial Secretary not later than 6:00 p.m. on the Monday preceding the set of trials.

Move-ups may be e-mailed, mailed or faxed. Verbal move ups will not be accepted. Please include basic (legible) information: Owner's name, dog's registered name and call name, registration number, class change information. Confirmation of move-up will be sent via e-mail. If you have not received a confirmation of move-up by the Monday move-up deadline, please contact the Trial Secretary immediately.

Day-to-day move ups will be allowed between the trial dates and will be taken up to one-half hour after the conclusion of the last class each day. These move-ups must be submitted in writing at the trial site to the Trial Secretary.

**FROM DC/VIRGINIA:** From DC Beltway (I-495), take I-270 exit towards Frederick. From I-270, take Father Hurley Blvd/Damascus exit, which becomes Rt 27/Ridge Rd. Stay on Rt 27 North about 20 miles. After crossing intersection at Rt 26, continue on Rt 27 North about 2 miles. Turn right onto Magin Lane, which is directly across from Calvary Baptist Church. Follow agility signs, almost 1 mile.

**FROM BALTIMORE:** From Baltimore Beltway (I-695), take Exit 19 (I-795). Continue until I-795 ends, bearing right onto Route 140 West/Westminster. Follow Rt 140 west for about 10 miles. At Town Mall, get in right lane & take exit ramp to Route 27 South. At end of ramp, turn left onto Route 27. Go about 8 miles. Turn left onto Magin Lane, which is directly across from Calvary Baptist Church. Follow agility signs, almost 1 mile.

Notes from a Veterinarian are required for all refunds.

**Bitches in Season:** Bitches in season are not permitted to compete in agility trials. The Club will refund 50% of the entry fee for bitches unable to compete for that reason.

**Medical Condition:** Dogs that cannot compete due to an injury or illness where a veterinarian determines that the dog should not run will be given a partial refund (50%) of entry fees.

\*All veterinarian notes must be signed, dated after the closing date, on official business letterhead and presented to the Trial Secretary no later than one half hour prior to the start of judging on the first day of the trial. After that time, refund requests will not be accepted. Please note: Phone calls, "text only" emails and non-letterhead notes will not be considered. Vet notes may not be written by owner, handler or immediate family member.

### Online (Credit Card) Entries:

This trial is accepting online entries through LabTestedOnline.com.

During the first 48 hours after opening, the initial limit of entries designated as either online or paper will be as follows: Thirty percent (30%) of entries per day available for online entry, seventy percent (70%) of entries per day for paper entries. If either form of entry (paper or online) has not filled at the end of the 48 hour time period, the club reserves the right to decrease or increase either one accordingly.

Online Entries will receive a confirming email from LabTestedOnline which will be considered the initial entry confirmation. All changes to online entries before closing **MUST** be done through the online entry website to ensure that payment is correct. Final confirmation will be received from the Trial Secretary at closing.

**PLEASE MAKE YOUR ENTRIES LEGIBLE.** Illegible entries will not be processed and will be returned to the exhibitor. Owners/Exhibitors are responsible for errors on entry forms. (Rules Applying to Dog Shows, Chapter 11, Section 6.)

Returned checks or postdated checks **do not** constitute a valid entry fee. The Trial Secretary will add a \$30.00 collection fee to the amount of each returned check. (Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.)

Due to the cost of processing, over-payments of \$5 or less will be donated to Sheltie Rescue.

## Notice to Exhibitors

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge they are familiar with the rules and regulations of this sport, and their dogs are familiar with and able to perform all obstacles safely.

### **Crating/Parking Information:**

No set-up time available on Wednesday evening. No overnight parking allowed.

**All competitors must park and unload on the grass in designated areas ONLY.**

The site is a Christmas tree farm. **Do NOT allow your dogs to relieve themselves on the Christmas trees!**

The road to the agility site is a single-lane driveway with a speed limit of 15 miles per hour. **Please go SLOWLY and watch for on-coming vehicles.**

No food vendor on site. A light lunch will be available to all workers. A convenience store with sandwiches and subs is 1 mile away, a pizza restaurant is 2 miles away.

Crate aggressive dogs must be covered and may not be positioned on the corners of aisles or other heavy traffic areas. This will be strictly enforced. If complaints are received, dogs will be moved.

Smokers, please be considerate and pick up your cigarette butts.

Puppies under 4 months are strictly prohibited from the grounds, and will be excused from the crating area.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by action of the Event Committee.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the trial grounds.

All dogs must be on a leash at all times except when in the ring or when in the designated agility warm-up area.

Exhibitors are responsible for being at the ring gate when it is their turn to run.

Returned checks do not constitute a valid entry fee. The Trial Secretary will add a \$30.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY basis.

Dogs **MAY NOT** be left overnight. The Shetland Sheepdog Club of Greater Baltimore will not be responsible for any lost or damaged items left at the trial site.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

INSTRUCTIONS

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division. All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option.
