CHECK-IN FOR MEASURING: If you did not indicate a permanent height card on your entry, your dog will have to be measured by the judge. There will not be a Volunteer Measuring Official (VMO) at the trial. It is the exhibitor's responsibility to have their dog measured prior to their run.

Measuring and check-in times are: Friday, Saturday, and Sunday: 7:15 – 8:00 a.m.
Measuring will also occur periodically during the day at the judge's discretion between classes.

COVID INFO:

IMPORTANT: If you are exhibiting signs of illness or have been otherwise told to self-quarantine due to known COVID-19 exposure, please stay home.

Social distancing guidelines should still be followed as much as possible with people outside your immediate social/family circle. This includes interactions with judges, club officials, volunteers and other exhibitors.

Mask Policy: All those unvaccinated should wear a properly fitting mask (covering both nose and mouth) in indoor settings and when unable to social distance.

SET-UP: Thursday, November 4: After setting rings which will begin at 4:00 p.m.

CLOCKS WILL BE TURNED BACK ON SATURDAY NIGHT.

VOLUNTEERS:

We are not assigning volunteers ahead of time. Volunteers may sign up the day of trial to pick the jobs they would like to do. It takes a lot of people to run a trial smoothly, so we appreciate everyone who can lend a hand.

MOVE-UPS:

Dogs may be moved up to a higher class at the request of the owner as a result of qualifying for any agility title provided that the request is made in writing to the Trial Secretary no later than 6:00 p.m. on November 1st for the November 5th trial.

Move-ups may be e-mailed to agilitysec@clantyre.net. Move-ups for Saturday and Sunday will be accepted prior to end of classes on Friday and Saturday.

TENTING / CRATING / WATER:

All classes will be held indoors on dirt. You may crate your dogs inside on dirt flooring.

FOOD:

There will be no food vendor at this trial. Please plan accordingly.

ATTENTION: This is a private farm which allows dogs only in certain areas of the farm. Please abide by all signs / rules of the farm. Please be sure to clean up after your dog!

IMPORTANT RV INFORMATION:

DO NOT ARRIVE PRIOR TO 3:00 PM on Thursday. If you do, you may be asked to move.

Overnight RV parking is allowed in designated area at the daily rate of \$20 with electric / night; \$10 no electric / night. All electric spots have been reserved, but there is space available for non-electric hook-ups. Be sure to e-mail Linda Syner at jagman3@comcast.net that you will be bringing an RV. Because this is a private farm (the owners' dogs will wake them if you arrive late), you **MUST ARRIVE BEFORE 10:00 PM. IF YOU ARRIVE AFTER 10:00 PM, FUTURE ENTRIES TO TKC TRIALS WILL NOT BE ACCEPTED. Spaces MUST be reserved in advance (NO EXCEPTIONS).**

DIRECTIONS TO TEST SITE

From the North via Route 113S: Take Rte 113S / Rte 1 South to Frederica. Turn right onto Rte 12 thru Frederica. Rte 12 will turn right in Frederica onto E. Front Street. Follow Rte 12 approximately 2.7 miles. Turn right onto Robbins Road. The site is on the right.

From the South via Route 113 N: Take Rte 113N to Frederica. Turn left onto Frederica Road. Turn right to remain on E. Front Street (Rte 12 W) and follow for 2.7 miles. Turn right onto Robbins Road. Site is on the right.

From the South Via Route 13 N: Take Rte. 13N to Felton. Turn right onto Midstate (Rte 12). Go approximately 3 miles. Turn left onto Robbins Road. Site is on right.

From the West (Bay Bridge): Take Route 50 East to Route 404 East . Exit 404 at MD 313N. Turn right onto MD 317. MD 317 changes to Rte 14 in Delaware. Follow DE 14 through Harrington to Rt. 13N. Follow directions from the South via Route 13 N.
