Armband Numbers and Check-In: Armbands will be available at the check-in table (alphabetical by **owner**).

Check-in for measuring: Begins on each day at 7:15 a.m. Additional measuring time will be provided (as available) as courses are being set. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. There will be 2

Volunteer Measuring Officials (Kim Reeher and Blair Kelly) present at the trial.

Reminder: All exhibitors should carry their dog's original AKC official Jump Height Card with them to each trial, in order to present the card, should they be asked, upon request.

Move ups for the June 18 trial must be received by 6 p.m. on Monday, June 13. Day-to-day move ups will be allowed and must be submitted in person to the trial secretary within ½ hour of the conclusion of judging each day.

Directions: From Pittsburgh and South: Take Route 28 north* to the Harmar exit. Turn left onto Route 910 and proceed for approximately ¼ mile until you almost reach the crest of the hill. Turn right onto Rich Hill Road. The facility is on the right after you cross the Turnpike.

**Allow additional travel time for heavy traffic, since there is construction on Rt. 28, the main road north from Pittsburgh to show site.*

From the Pennsylvania Turnpike: Leave the Turnpike at Exit 48 and follow signs to Pittsburgh. Travel approximately ½ mile until Route 910 leads off to the right. Turn right onto Route 910 and follow the directions above.

Directions: South on Rich Hill Rd. toward Jacoby Rd. Turn Left onto PA-19/Indianola Rd./Yellow Belt. Turn Left onto Freeport Rd. Merge onto I-76E/PA Turnpike toward Harrisburg/Exits 57-359. Take the I-376W exit #57 toward Pittsburgh/Monroeville. Take the US-22-BR exit #16 on Left toward Monroeville. Merge onto US-22 BR. Turn Left onto PA-48/mosside Blvd./Orange Belt. Turn Right onto Northern Pike. 4224 Northern Pike is on the Left.

FAST: One walk-through for each level (Excellent, Open, Novice)
