Armband Numbers and Check-In: Armbands will be available at the check-in table (alphabetical by owner).

Check-in for measuring: Begins on each day at 7:15 a.m. Additional measuring time will be provided (as available) as courses are being set. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. There will be a **Volunteer Measuring Official** (Blair Kelly) present at the trial.

Reminder: Exhibitors should carry the original valid official Jump Height Card at each trial to present upon request.

Move ups for the June 16 trial must be received by 6 p.m. on Monday, June 11. Day-to-day move ups will be allowed and must be submitted in person to the trial secretary within ½ hour of the conclusion of judging each day.

Directions: From Pittsburgh and South: Take Route 28 north* to the Harmar exit. Turn left onto Route 910 and proceed for approximately ¼ mile until you almost reach the crest of the hill. Turn right onto Rich Hill Road. The facility is on the right after you cross the Turnpike.

***Allow additional travel time, since there is construction on Rt. 28, the main road north from Pittsburgh to show site.**

From the Pennsylvania Turnpike: Leave the Turnpike at Exit 48 and follow signs to Pittsburgh. Travel approximately ½ mile until Route 910 leads off to the right. Turn right onto Route 910 and follow the directions above.

Judging Schedule

Running Order as of June 6, 2012

Preliminary running order, contingent on move-up entries and post-closing waitlist adjustments not yet received.

The first official briefing and walk-through will begin each day at 7:45 a.m.
Judging will begin at **8:00 a.m.** each day in Ring 1, **8:30 a.m.** each day in Ring 2.

Jump Height Order: Small-Tall both days

Walk-Throughs:

Novice & Open (STD and JWW): all heights walk together
Excellent (STD and JWW): 4/8 & 12 will walk/walk-run/run*, 16, 20, 24/26
FAST: One walk-through for each level (Excellent, Open, Novice)

*The 4/8" dogs will walk followed immediately by the 12" walk. All three height classes will run back to back with no break.

Please be on the line at least 4 dogs before your turn to go.
If you have a conflict, please make every effort to walk with an *earlier* group
to ensure the smooth running of the trial and timely results for each height division. Thank you!!

Take the I-376W exit #57 toward Pittsburgh/Monroeville. Take the US-22-BR exit #16 on Left toward Monroeville. Merge onto US-22 BR. Turn Left onto PA-48/Mossy Side Blvd./Orange Belt. Turn Right onto Northern Pike. 4224 Northern Pike is on the Left.
