Armband Numbers and Check-In: Armbands will be available at the check-in table (alphabetical by owner).

Check-in for measuring: Begins on Saturday day at 8:00 a.m. and Sunday at 7:00 a.m. Additional measuring time will be provided (as available) as courses are being set. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. (We will have a VMO available. Any dog that needs to be measured will need to be measured before they run.)

Reminder: **Exhibitors should carry the original valid official Jump Height Card at each trial to present upon request.**

Move ups for the June 13 trial must be received by 6 p.m. on Monday, June 8. Day-to-day move ups will be allowed and must be submitted in person to the trial secretary within ½ hour of the conclusion of judging each day.

Directions: From Pittsburgh and South: Take Route 28 north* to the Harmar exit. Turn left onto Route 910 and proceed for approximately ¼ mile until you almost reach the crest of the hill. Turn right onto Rich Hill Road. The facility is on the right after you cross the Turnpike.

From the Pennsylvania Turnpike: Leave the Turnpike at Exit 48 and follow signs to Pittsburgh. Travel approximately ½ mile until Route 910 leads off to the right. Turn right onto Route 910 and follow the directions above.

Turn Right onto Northern Pike. 4224 Northern Pike is on the Left. Approximate travel estimate: 13.57 miles, 20 minutes.

Running Order as of June 3, 2015

Preliminary running order, contingent on move-up entries and not yet received. (There is no post-closing waiting list.)

The first official briefing and walk-through will begin:

Saturday: Ring 1 at 9:30 a.m. :: Ring 2 at 9:00 a.m.

Sunday: Ring 1 at 8:30 a.m. :: Ring 2 at 8:00 a.m.

Jump Height Order: Small-Tall both days

Walk-Throughs:

Novice & Open (STD and JWW) : all heights walk together

Exc/Master (STD and JWW): 4/8, 12, 16, 20, 24/26

FAST: One walk-through for each level (Exc/Master, Open, Novice)

Time2Beat walk-throughs will be at judge's discretion.

Please be on the line at least 4 dogs before your turn to go.

If you have a conflict, please make every effort to walk with an *earlier* group to ensure the smooth running of the trial and timely results for each height division. Thank you!!
