Armband Numbers and Check-In: Armbands will be available at the check-in table (alphabetical by owner).

Check-in for measuring: Begins on Saturday day at 8:00 a.m. and Sunday at 7:00 a.m. Additional measuring time will be provided (as available) as courses are being set. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. We are not expected to have a VMO available at the trial. Any dog (except for those entered in the 24/26" regular or 20" preferred height) that needs to be measured will need to be measured by one of the judges before run. This measurement will be good for this weekend of trials only.

Reminder: **Exhibitors should carry the original valid official Jump Height Card at each trial to present upon request.**

Move ups for the June 18 trial must be received by 6 p.m. on Monday, June 13. Day-to-day move ups will be allowed and must be submitted in person to the trial secretary within ½ hour of the conclusion of judging each day.

From the East: Take I-70/US 30 W. Continue to follow US-30 W. Merge onto PA-982 toward Bradenville (go 1.0 Miles). Turn LEFT onto LIGONIER ST. (LIGONIER is just past DIANE St.) (Go 0.3 Miles). Turn LEFT onto AVENUE B. (AVENUE B is just past AVENUE C) (go 0.3 Miles). 501 AVENUE B is on the RIGHT. (Destination is just past WATKINS AVE.) (Go 0.01 Miles)

From the West: Take US-22 E. Turn RIGHT onto PA-981 (go 6.5 Miles). Turn Right onto PA-981/Industrial Blvd. Continue to follow PA-981 S (go 0.5 Miles). Turn LEFT onto LINCOLN AVE./PA-981. Continue to follow LINCOLN AVE. (Lincoln AVE. is just past DEPOT St.) (Go 0.9 Miles). Turn RIGHT onto Cedar ST. (CEDAR ST. is 0.1 miles past CHERRY ST). (Go 0.1 Miles). Turn LEFT onto LIGONIER ST. (go 0.3 Miles). Turn RIGHT onto AVENUE B (AVENUE B is just past AVENUE A) (go 0.3 Miles). 501 AVENUE B is on the RIGHT. (Destination is just past WATKINS AVE.) (Go 0.01 Miles).

From the North: Take I-76 S (Pennsylvania Turnpike). Merge onto US-30 E via EXIT 67 toward GREENSBURG (go 18.9 Miles). Merge onto PA-982 toward Bradenville (go 1.0 Miles). Turn LEFT onto LIGONIER ST. (LIGONIER is just past DIANE St.) (Go 0.3 Miles). Turn LEFT onto AVENUE B. (AVENUE B is just past AVENUE C) (go 0.3 Miles). 501 AVENUE B is on the RIGHT. (Destination is just past WATKINS AVE.) (Go 0.01 Miles)

From the South: Take US-119 N. Merge onto US-30 E. Merge onto PA-982 toward Bradenville (go 1.0 Miles). Turn LEFT onto LIGONIER ST. (LIGONIER is just past DIANE St.) (Go 0.3 Miles). Turn LEFT onto AVENUE B. (AVENUE B is just past AVENUE C) (Go 0.3 Miles). 501 AVENUE B is on the RIGHT. (Destination is just past WATKINS AVE.) (Go 0.01 Miles)

Crating/setup: Exhibitor Setup on Friday Evening: 5:30 – 6:30 p.m. Those exhibitors who come in and help unload the equipment trailer will be given priority at set-up time. ☺ The building will be open at 7:00 a.m. on Saturday and Sunday mornings.

The first official briefing and walk-through will begin:

Saturday: Ring 1 at 9:30 am :: Ring 2 at 9:00 am

Sunday: Ring 1 at 9:00 am :: Ring 2 at 8:30 am

Jump Height Order: Small-Tall both days

Walk-Throughs:

Novice, Open (STD and JWW), Premier JWW, Time2Beat : One walk-through per class

Exc/Master (STD and JWW), two walkthroughs: 4/8/12, 16/20/24

FAST: One walk-through for each level (Exc/Master, Open, Novice)

Please be on the line at least 4 dogs before your turn to go.

If you have a conflict, please make every effort to walk with an *earlier* group to ensure the smooth running of the trial and timely results for each height division. Thank you!!
