Check-in:

Your check-in will be at the gate sheets and are for check-in *only*. Any changes in running order must be done by the Gate Steward for the class.

<u>Check-in for measuring</u>: Begins on Friday at 8:30 AM, Saturday and Sunday 8:00 AM. Additional measuring time will be provided (as available) as courses are being set. A VMO will be present at the trial all three days. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Reminder: Exhibitors should carry the original valid official Jump Height Card at each trial to present upon request.

<u>Move ups</u> for the June 14 trial must be received by 6:00 PM on Monday, June 10. Day-to-day move ups will be allowed and must be submitted in person to the trial secretary within ½ hour of the conclusion of judging each day.

From the East: Take I-70/US 30 W. Continue to follow US-30 W. Merge onto PA-982 towardBradenville (go 1.0 Miles). Turn LEFT onto LIGONIER ST. (LIGONIER is just past DIANE St.) (Go0.3 Miles). Turn LEFT onto AVENUE B. (AVENUE B is just past AVENUE C) (go 0.3 Miles). 501 AVENUE B is on the RIGHT. (Destination is just past WATKINS AVE.) (Go 0.01 Miles)

From the West: Take US-22 E. Turn RIGHT onto PA-981 (go 6.5 Miles). Turn Right onto PA-981/Industrial Blvd. Continue to follow PA-981 S (go 0.5 Miles). Turn LEFT onto LINCOLN AVE./PA-981.Continue to follow LINCOLN AVE. (Lincoln AVE. is just past DEPOT St.) (Go 0.9 Miles). Turn RIGHTonto Cedar ST. (CEDAR ST. is 0.1 miles past CHERRY ST). (Go 0.1 Miles). Turn LEFT ontoLIGONIER ST. (go 0.3 Miles). Turn RIGHT onto AVENUE B (AVENUE B is just past AVENUE A) (go 0.3 Miles). 501 AVENUE B is on the RIGHT. (Destination is just past WATKINS AVE.) (Go 0.01Miles).

From the North: Take I-76 S (Pennsylvania Turnpike). Merge onto US-30 E via EXIT 67 towardGREENSBURG (go 18.9 Miles). Merge onto PA-982 toward Bradenville (go 1.0 Miles). Turn LEFTonto LIGONIER ST. (LIGONIER is just past DIANE St.) (Go 0.3 Miles). Turn LEFT onto AVENUE B.(AVENUE B is just past AVENUE C) (go 0.3 Miles). 501 AVENUE B is on the RIGHT. (Destination isjust past WATKINS AVE.) (Go 0.01 Miles)

From the South: Take US-119 N. Merge onto US-30 E. Merge onto PA-982 toward Bradenville (go1.0 Miles). Turn LEFT onto LIGONIER ST. (LIGONIER is just past DIANE St.) (Go 0.3 Miles). TurnLEFT onto AVENUE B. (AVENUE B is just past AVENUE C) (Go 0.3 Miles). 501 AVENUE B is onthe RIGHT. (Destination is just past WATKINS AVE.) (Go 0.01 Miles)

Running Order as of June 4, 2019

Preliminary running order, contingent on move-ups not yet received. (There is no post-closing waiting list.)

Walk-Throughs:

Novice, Open (STD and JWW), Premier STD & JWW, Time2Beat: One walk-through per class Exc/Master (STD and JWW), two walk-throughs: 4/8/12, 16/20/24/24C. FAST (combined course) will have one walk-through for all levels. Additional walk-throughs at the discretion of the judge.

Please be on the line at least 4 dogs before your turn to go.

CONFLICT MANAGEMENT:

Please mark a "C" on each gate sheet to alert the steward that you have a potential conflict. If you have a conflict that cannot be resolved easily, please walk and run with an *earlier* group. We will be carefully monitoring the rings and will "pause" one ring if we need to.
