#### Check-in:

Your check-in will be at the gate sheets and are for check-in \*only\*. Any changes in running order must be done by the Gate Steward for the class.

**<u>Check-in for measuring</u>:** Begins on Friday at 7:30 a.m., Saturday and Sunday at 7:00 a.m. Additional measuring time will be provided (as available) as courses are being set. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. We do not expect a VMO to be present at this trial, so any dog (excluding dogs entered in the 24" and 26" height) will need to be measured by one of the judges. This measurement will be good for this weekend of trials ONLY. Reminder: All exhibitors should carry their dog's original AKC official Jump Height Card with them to each trial, in order to present the card, should they be asked, upon request.

<u>Move ups</u> for the May 19 trial must be received by 6 p.m. on Monday, May 15 (no exceptions). Move-ups for Friday-Saturday or Saturday-Sunday will be allowed and must be submitted within ½ hour of the end of judging each day. The move-up book will be located on the check-in table. Just fill out your move-up form and leave it in the book. Magically, your move-up will happen overnight. ©

#### Directions: The Frederick Indoor Sports Center is located at 1845 Brookfield Ct., Frederick, MD 21701.

From Route 70, merge onto US-40 toward US-15 N/Gettysburg (US-40 becomes US-15 N). Merge onto MD-26 E/Liberty Rd. via Exit 17 toward MD-194/Libertytown/Walkersville. Take the 1<sup>st</sup> right onto Routzahns Way/MD-355. Take 1<sup>st</sup> right onto Wormans Mill Ct. Take the 1<sup>st</sup> left onto Brookfield Ct. FISC is on the right.

Food and refreshments will be available at the trial site. There is a new food vendor, P.I.G.S. BBQ, and the menu looks great! Note: The restaurant opens at 11:00 AM, so breakfast will not be available. https://media.frederickindoor.com/uploads/pigs\_menu.pdf

<u>Crating/setup</u>: The building will be open to agility exhibitors each day at 7:00 a.m. Please note that although the doors are sometimes open earlier for other activities in the building, the club needs to complete ring and equipment set-up before exhibitors will be allowed on the field. NO SET-UPS or site accessibility on Thursday evening. Water ONLY in the crating area, please.

#### We will be required to COMPLETELY CLEAR the ring at the end of the Friday trial for another scheduled event. Items will need to be completely removed (including all mats, crates, chairs, etc.) by 6:00 PM. We will not have to clear the ring on Saturday. FISC has made accommodation for those exhibitors crating upstairs, and there will be a place to stash things if they need to utilize the field in the evening.

The Saturday and Sunday trials are full, which makes crating space on the field limited. Please plan on getting cozy with your neighbor and sharing where you can. There is additional crating space upstairs. Usually, the facility has a space for us to store our gear Friday night. Ask a committee member and we'll be able to point you in the right direction.

<u>We wish to thank all those who have volunteered to help at this trial</u>. Any and all assistance makes for a smoother running trial, so please check with the volunteer coordinator in each ring often to see how you can help! Volunteers will receive a coupon for each class worked that can be used for future entries or at the P.I.G.S. Restaurant located inside the facility.

Volunteering just got easier! The Volunteer sheets will be posted at the trial site each day. You can go in and fill in your name where you'd like to work, with our thanks!


# **Parking - Special Instructions**

The parking map below clearly outlines available parking. The facility marks spaces that are used for their tenants and employees, so please be sure to respect those signs. The spaces marked "Reserved for exhibitors working from their cars" (this map is used year-round) may be used for that purpose ONLY if the weather permits. They will not be policed; it's an "honor system" style of parking. © Even though it can be a little tight, there is sufficient room inside, so we encourage you to crate inside where it's cool if the temperature goes crazy as it sometimes does.

Do not park in the parking areas of the businesses directly across from the Sports Center. You WILL be towed.

Unloading: You may unload at the front entrances. There is an entrance/exit on the left side of the building that is sometimes available. Please respect any door that is marked as an Emergency Exit, and do not use it as a normal exit.

<u>Motorhome Parking</u>: Parking for Motorhomes is available at the show site (in the area marked "Overflow Parking") for Thursday, Friday and Saturday nights. Motorhome parking is limited ONLY to those spaces in that are marked "Overflow Parking." No hookups, no electricity, no dumping. *There may be locked gate at the entrance to the Overflow Parking Area. The combination is available at the front desk of FISC, and they are normally open until 11:00 PM.*
