**IMPORTANT:** If you are exhibiting signs of illness or have been otherwise told to self-quarantine due to known COVID-19 exposure, please stay home. As of the publishing of this judging schedule, wearing of masks in the building is optional. We will follow the facility, state and local mandates at the time of the trial. Signs will be posted if anything changes. Please come prepared with a mask just in case.

<u>Crating/setup</u>: The building will open at 6:45 AM each morning. NO SET-UPS or site accessibility on Thursday evening. There is plenty of room for indoor cratng! Crating will be allowed on the field to the left and the basketball court. Crates will <u>not</u> be allowed on the agility field – chairs ONLY. Take your chair with you each evening – we must clear the field for a soccer event on Friday evening.

Volunteers who are willing to help with set-up and course build each morning will be allowed to enter the building at 6:30 AM.

<u>Course maps</u>: Paper course maps will not be available. Courses will be posted each day after midnight. Click on the Blog tab in the upper right on the Home page. When you get to the Blog page click on the trial.

NOTE: AKC is no longer allowing course maps to be provided the evening before the trial. They will be posted at the trial site, as well, so come prepared to photograph the map for personal use.

Briefings/walkthroughs: See judging schedule page for briefing/walkthrough schedule.

<u>Check-in:</u> Regular paper gate sheets will be available for check in. (We are not using an electronic check-in system.) Any changes in running order must be made by the Gate Steward for the class.

<u>Measuring:</u> A Measuring Official is **not** expected to be present at this trial. NOTE: The AKC has returned to the policy of measuring all dogs that do not have a height card. Even if a VMO is not present, all dogs that do not have a height card will need to be measured by the judge of record (if no VMO is present) prior to their first run. This measurement will be good for this weekend of trials only.

Move ups for the May 17 trial must be received by 6 p.m. on Monday, May 13. Move-ups for Friday-Saturday or Saturday-Sunday will be allowed and must be submitted within ½ hour of the end of judging each day. The move-up book will be located near the Secretary table – just look for the monitors. Just fill out your move-up form and leave it in the book. Magically, your move-up will happen overnight. ©

Parking: There is plenty of parking. RV parking is by reservation only (see premium for details).

Food and refreshments will be available at the trial site at the on-site restaurant.

Recording/videoing for personal use is not prohibited as long as it does not obstruct aisles/walkways, disturb other exhibitors, dogs, or judge(s). Those using video must be cognizant of both intentional and ambient audio. These devices may not be used near the trial secretary/judge/club working areas or placed behind timer/scribe working in the ring.

We wish to thank all those who have volunteered to help at this trial. Any and all assistance makes for a smoother running trial, so please check with the volunteer coordinator in each ring often to see how you can help! Volunteering just got easier! The Volunteer boards will be posted for each ring at the trial site each day. You can go in and fill in your name where you'd like to work, with our thanks!

Remember! Keep the area clean! As always, exhibitors are responsible for cleaning up any deposits left by their dog. Any exhibitor failing to pick up after their dog will be EXCUSED without benefit of refund if the Event Committee deems the exhibitor is in violation of this requirement. While the use of flexi-leads is not prohibited on show grounds, we urge you to use them responsibly. Failure to properly control a dog at an event can be grounds for a misconduct hearing. Let's keep this site dog friendly!

From **Baltimore**: From Baltimore Beltway (I-695) take Exit 19, Northwest Expressway (I-795) towards Owings Mills/Reisterstown. Continue until the Expressway ends, bear right onto Route 140 West. Follow 140 West for approx. 10 miles, turn left onto Route 97 (Weis Market on right, PetSmart market on the left.) At the 2<sup>nd</sup> light, turn Left onto Old Westminster Pike. The Carroll Indoor Sports Center will be on the right a short distance after the turn.

From **DC & Virginia:** From DC Beltway (I-495) take I-270 exit towards Frederick. From 270, take Damascus exit (Route 27 North). Stay on 27 North approx. 25 miles to Main Street in Westminster. Turn right onto Main Street. Go 1.5 miles. C.I.S.C. will be on right side of road after crossing over Route 97.
