- **EARTHDOG REGULATIONS** may be obtained from the American Kennel Club, 8051 Arco Corporate Drive, Raleigh, NC 27617-3390. Telephone (919) 233-9780. (www.akc.org.)
- **ENTRY FEES** will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. No entry fee will be refunded if the trial cannot open or be completed by reasons of riot, civil disturbance, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organization committee.
- **Express Mail** entries *must* include signature permitting them to be left without recipient signature.
- **RETURNED CHECKS** do not constitute a valid entry fee. The Test Secretary will add a \$30.00 collection fee to the amount of each returned check.
- **EXHIBITORS should follow their veterinarian's recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.**

## ELIGIBILITY OF DOGS

**Dogs may enter only one regular class at an Earthdog test, except dogs which have earned a Master Earthdog title may enter more than one regular class.**

Master Earthdog is open only to dogs that have acquired the Senior Earthdog title before entries have closed or have been awarded the Master Earthdog title.

Senior Earthdog is open only to dogs that have acquired the Junior Earthdog title before the entries have closed and to dogs with Master or Senior Earthdog titles.

Junior Earthdog class is open to dogs that have not been recorded as or received qualifying scores in Senior Earthdog or Master Earthdog and to dogs that have acquired a Master Earthdog title.

Any dog, otherwise eligible, may enter Introduction to Quarry, (IQ) at the owner's discretion. IQ is a nonregular (practice) class. Dogs do not have to pass IQ to be entered in any of the other classes.

To participate, dogs must be at least 6 months old, registered (full or limited) with the AKC or an AKC recognized foreign registry or have been granted an ILP (Indefinite Listing Privilege) or PAL (Purebred Alternative Listing) number. Neutered or spayed dogs are allowed.

Bitches in season are not eligible to enter Earthdog Tests. There will be no refund of any entry fee in this case.

## ELIGIBLE BREEDS:

Dachshunds and Terrier Breeds: Australian, Bedlington, Border, Cairn, Cesky, Dandie Dinmont, Glen of Imaal, Parson Russell, Lakeland, Manchester, Miniature Bull, Miniature Schnauzers, Norfolk, Norwich, Rat, Russell, Scottish, Sealyham, Silky, Skye, Smooth Fox, Welsh, West Highland White and Wire Fox.

**Eligibility of Dogs:** Dogs 6 months of age or older that have been registered with the AKC, have been recorded with the Foundation Stock Service (FSS) or have an ILP or PAL granted by the AKC are eligible to participate. Dogs may be spayed and neutered. A dog, if an eligible breed with an acceptable foreign registration number, is eligible to participate, subject to Chapter 11, Sec. 1, of the Dog Show Rules.

## RIBBONS

The United States Lakeland Terrier Club offers a rosette to each dog that passes the Introduction to Quarry test and a rosette to each dog that qualifies in the Junior Earthdog, Senior Earthdog, or Master Earthdog test.

## TROPHIES

The **Border Terrier Club of America** offers a stuffed toy for all Border Terriers with a qualifying leg in any class and a BTCA logo key ring to all Border Terriers that earn a title.

The **United States Lakeland Terrier Club** offers a Club Medallion with USLTC logo to each Lakeland Terrier who qualifies in the regular classes.

The **Scottish Terrier Club of America** will award to each Scottie that earns a qualifying score in any regular class (JE, SE or ME) an item with the STCA Logo. For those Scotties that did not qualify last year, the item will be a Pewter Pencil Holder. For those who qualified last year, the item will be a choice of a Pewter Letter Opener, Pewter Paper Weight or a Pewter Stamp Holder.
