- Running Order: Listed below, with the first handler's meeting occurring no earlier than the posted time. There will be a separate handler's meeting held for each class before it begins. Judging will begin immediately after the handler's meeting.
- **Move-Ups**: Requests to move up must be given to the Herding Secretary at least 30 minutes prior to the start of the event.

There are 32 dogs pre-entered in the AM test with 32 total entries. There are 29 dogs pre-entered in the PM test with 29 total entries.

Day-of-show entries will be taken for the Instinct Test and must be received 30 minutes prior to the start of judging (8:00 AM for the morning test, 11:30 AM for the afternoon test). There is plenty of room!

DIRECTIONS

Keepstone Farm is located at 412 Russell Road, at Keepstone Farm in scenic Berryville, Virginia; less than a mile from Route 7 West. It is easily accessible from Northern Virginia, West Virginia and Frederick Maryland via major roadways.

From the East: From Leesburg VA, take Route 7 West. Passing 2 traffic lights after the Rt 340 exit for Berryville, turn Right on Russell Road (Rt 660).

**Go 3/10 mile, turn Right at large Keepstone Farm sign. Follow farm lane to Left turn at # 412, and go to end of Driveway.

From the West: From I-81, Take Exit 315, Rt 7 East at Winchester VA. Go about 6 miles, and turn Left on Russell Road (Rt 660). Follow ** directions above.

From the North: From Frederick MD, take Rt 340/15 South, bearing right on 340 South at the split. Follow 340 to Charles Town WV, and continue South on 340 to Rt 7 West at Berryville VA. Follow Rt 7 West through 2

traffic lights, to Russell Rd on right. Follow ** directions above.

From the South: From Rt 66 West - Take Rt 17 North toward Paris VA. Take 17 to traffic light, and turn Left onto Rt 50 West toward Winchester. Follow Rt 50 W to a Right turn at Rt 340 North. (Sheetz Station at light). After following through the towns of Boyce and Berryville, turn Left onto Rt 7 West. Follow ** directions above.
