From the North or South: Interstate 81, Exit 251 for US-11-South towards Harrisonburg. Use any lane to turn left onto US-11-S. Turn left onto Cornerstone Lane. Turn right to stay on Cornerstone Lane. Turn right. Destination will be on the right.

If you are exhibiting signs of illness or have been otherwise told to self-quarantine due to known COVID-19 exposure, please stay home. As of the publishing of this judging schedule, wearing of masks in the building is optional. We will follow the facility, state and local mandates at the time of the trial. Signs will be posted if anything changes. Please come prepared with a mask just in case.

Crating space will be available. The event site requires a tarp to be placed on the floor underneath your crates.

Spectators are encouraged. Any person not handling a dog in the current class, or any person who has already completed their run in the class may choose to watch the search from the spectator area. Handlers may not watch other exhibitors from their class prior to their run. No one outside the search area may assist the handler or disclose the location of the hide.
