Obstacle Use for Course D: In addition to the seven required elements, the following elements may be used in any combination: Gate Sort, Extra Obstacles, Figure 8, Mock Footbath, Alleyways (Maltese Cross) and Freestanding pen. Courses are pre-designed, will be randomly selected by the judge, and are subject to judge tweak and approval. Courses will be posted one hour prior to the start of judging.

**** ADVANCED HANDLERS **** per the AKC, if your dog earns an advanced title on the day of the trial, the dog is not eligible for HC points on that course/stock until the following day. ALSO, we have discovered the AKC is not keeping accurate records for Championship points. It is possible that the free "Points Progression" offered on the AKC website has over-calculated the points, while their internal software has a different number of points. PLEASE contact AKC directly to ensure your points have been accounted for. See Rachael if you need clarification on this.

Limited Entry

Entries are taken in the order received. No priority is given to any one type of entry over another.

- 50 runs per judge, per day*
- Duck limit: 36 runs total per day
- Cattle limit: 12 runs total per day
- Course D Ranch, 10 runs per day

* Each ranch run will count as 1.5 regular runs. For every two ranch entries, the total daily limit will be decreased by one run, for a potential for only 45 daily runs per judge.

Telegraph, telephone and unsigned entries cannot be accepted. Entries not on an official AKC entry form and photocopies of entry forms without agreement and rules on the reverse side of the official AKC entry form are NOT ACCEPTABLE. Entries received without fees will not be accepted. Acknowledgement of entries will be made via email as soon as practicable. Please include legible e-mail address on your entry form.

Returned checks or chargebacks do not constitute a valid entry fee. The Show Secretary will add a \$30 collection fee to the amount of each returned check or chargeback. Entry fees will not be refunded in the event that a dog is absent, disqualified, or excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee. No refunds for bitches in season. If because of riots, civil disturbances, or other acts beyond the control of the show giving club, it is impossible to open or complete the show, no refunds will be made. Event Service Fees on herding events will be \$3.50 per entry. (*American Kennel Club Herding Regulations, Chapter 1, Section 16.*)

Credit Card Payment

Online Payment will be accepted up to the closing date and time via PayPal. Do not email or fax your credit card numbers to us. Entry forms may be scanned and emailed to clantyre.showsec@gmail.com, or mailed to the address above.

Official AKC entry forms must be used and both sides must be transmitted.

Payment can be made through the Clantyre Website. Credit card entries will include a \$2.50 fee for each entry. If you prefer to be invoiced, please include that in your email and an invoice will be sent as soon as practicable. Entries are not processed until payment is made. Eligibility of Dogs

Trial levels, HT and PT are open to all herding breeds nine (9) months of age or older that are registered with The American Kennel Club or have been granted an ILP\PAL and are eligible to compete in herding trials and tests under Chapter 1, Section 3 of the AKC Herding Regulations.

The Herding Instinct Test is open to all herding breeds six (6) months of age or older that are registered with The American Kennel Club or have been granted an ILP\PAL and are eligible to compete in herding trials and tests under Chapter 1, Section 3 of the AKC Herding Regulations.

Livestock

Sheep and ducks will be provided by Susan Rhoades, Keepstone Farm

Sheep (Mixed breed hair & wool sheep).....	3-5 sheep/run in trial classes (Value of sheep: \$350 each)
Ducks (Blue Swede and Blue Swede hybrids or Indian Runners) .	4-5 ducks per run (Value of ducks: \$50 each)
Cattle (Beef & Dairy mixes).....	3 cattle per run (Value of cattle: \$1200 each)

Notice to Exhibitors

- Bitches in season shall be eligible and will be run at the end of their level in tests, in catalog order at the trial level.
- There will be no smoking at the show site. Please dispose of trash in the proper manner. Bring shade, water and chair. Event will be held rain or shine.
- All dogs present which are not being worked in the arena must be kept quiet, off course, on leash and away from the fences. Please do not allow them to disturb the resting stock or interfere with the working dog.
- Judges are not required to wait for dogs. It is the responsibility of the owner/handler to have the dog at ringside when required and without being called.
- Exhibition Only Day-of entries will be offered if entries have not reached the numerical limits and must be received by the trial secretary by 8:00 a.m.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The host club, Clantyre Show Secretary Services and its agents, employees, etc. will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

Closing of Entries/Alternates and Move-Ups

(AKC Herding Rules & Regulations, Section 13):

- Whenever trial entry limits have been reached all additional entries that are received prior to the closing date shall be added to an alternate's list for each level that exceeds the published limit (s). This trial will keep an alternate list of five (5) runs per stock/course.
- Entrants on the alternates list must check in with the Herding Secretary on the grounds no later than 30 minutes before the commencement of their class.
- Entry fee will be refunded to the alternates whose dogs do not have an opportunity to run.
- Requests for move-up must be given to the Herding Secretary at least 30 minutes prior to the start of the event.

Refund Policy

- Entry fees will not be refunded in the event that a dog is absent, disqualified, or excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee.
- If because of riots, civil disturbances, or other acts beyond the control of the show giving club, it is impossible to open or complete the show, no refunds will be made.
- Refunds of entries pulled after closing date will be made as long as an alternate is available to replace the run; if no alternate runs, no refund will be given.
- No refund for duplicate entries or any other cause beyond the control of the BRHA after the closing date (Rules Applying to Dog Shows, Chapter 11, Section 6) including injured or sick dogs or handlers. In the event of a spouse, sibling, parent or entered dog's untimely death, an event committee decision will be made.
- Declination of entries: The BRHA may decline any entries for cause and may remove any dog on account of disease, viciousness, or other cause and no one shall have any claim or recourse against the BRHA or any official thereof. In this case, no refund will be made.

AGREEMENT

I (we) agree that the club holding this event has the right to refuse entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend, and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN ITS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTREPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. A dog must be entered in the name of the person who actually owned it at the time the entries for a show closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of the acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to A.K.C. (For complete rule refer to Chapter 11, Section 3).

Directions

Keepstone Farm is located at 412 Russell Road, in scenic Berryville, Virginia; less than a mile from Route 7 West. It is easily accessible from Northern Virginia, West Virginia and Frederick Maryland via major roadways.

From the East: From Leesburg VA, take Route 7 West. Passing 2 traffic lights after the Rt 340 exit for Berryville, turn Right on Russell Road (Rt 660).

* Go 3/10 mile, turn Right at large Keepstone Farm sign (Dog Gone Healthy sign below). Follow farm lane to Left turn at #412, and go to end of Driveway.

From the West: From I-81, Take Exit 315, Rt 7 East at Winchester VA. Go about 6 miles, and turn Left on Russell Road (Rt 660). Follow * directions above.

From the North: From Frederick MD, take Rt 340/15 South, bearing right on 340 South at the split. Follow 340 to Charles Town WV, and continue South on 340 to Rt 7 West at Berryville VA. Follow Rt 7 West through 2 traffic lights, to Russell Rd on right. Follow * directions above.

From the South: From Rt 66 West - Take Rt 17 North toward Paris VA. Take 17 to traffic light, and turn Left onto Rt 50 West toward Winchester. Follow Rt 50 W to a Right turn at Rt 340 North (Sheetz Station at light). After going through the towns of Boyce and Berryville, turn Left onto Rt 7 West. Follow * directions above.
