Notice to Exhibitors

- Bitches in season shall be eligible and will be run at the end of their class.
- There will be no smoking at the trial site. Please dispose of trash in the proper manner. Bring shade, water and chair. Event will be held rain or shine.
- All dogs present which are not being worked in the arena must be kept quiet, off course, on leash and away from the fences. Please do not allow them to disturb the resting stock or interfere with the working dog.
- Judges are not required to wait for dogs. It is the responsibility of the owner/handler to have the dog at ringside when required and without being called.
- Exhibition Only Day-of entries will be offered if entries have not reached the numerical limits and must be received by the trial secretary by 8:00 a.m.

Closing of Entries/Alternates and Move-Ups

(AKC Herding Rules & Regulations, Section 13):

- Whenever trial entry limits have been reached all additional entries that are received prior to the closing date shall be added to an alternate's list for each level that exceeds the published limit (s). This trial will keep an alternate list of five (5) runs per stock/course.
- Entrants on the alternates list must check in with the Herding Secretary on the grounds no later than 30 minutes before the commencement of their class.
- Entry fee will be refunded to the alternates whose dogs do not have an opportunity to run.
- Requests for move-up must be given to the Herding Secretary at least 30 minutes prior to the start of the event.

Refund Policy

- Entry fees will not be refunded in the event that a dog is absent, disqualified, or excused by the Judge or Veterinarian, or barred from competition by action of the Trial Committee.
- If because of riots, civil disturbances, or other acts beyond the control of the show giving club, it
 is impossible to open or complete the show, no refunds will be made.
- Refunds of entries pulled after closing date will be made as long as an alternate is available to replace the run; if no alternate runs, no refund will be given.
- No refund for duplicate entries or any other cause beyond the control of the BSCA after the closing date (Rules Applying to Dog Shows, Chapter 11, Section 6) including injured or sick dogs or handlers. In the event of a spouse, sibling, parent or entered dog's untimely death, an event committee decision will be made.

Eligibility of Dogs

Trial levels, HT and PT are open to all Belgian Sheepdogs nine (9) months of age or older that are registered with The American Kennel Club or have been granted an ILP\PAL and are eligible to compete in herding trials and tests under Chapter 1, Section 3 of the AKC Herding Regulations.

The Herding Instinct Test is open to Belgian Sheepdogs six (6) months of age or older that are registered with The American Kennel Club or have been granted an ILP\PAL and are eligible to compete in herding trials and tests under Chapter 1, Section 3 of the AKC Herding Regulations.

Drawing for Run Order

Drawing for run order shall be held at 5474 Delphinium Court, Columbia, MD 21045 on Tuesday, April 5, 2016 at 6:00 p.m.

What Do I Enter?

Herding Instinct Test*

(No previous experience is necessary!) The Instinct Test is held in a small pen, either round in shape or with rounded corners, which can vary in size from 50×50 feet, up to 100×100 feet. Livestock used can be cattle, sheep or ducks. The dog will enter the pen on a 6-15 foot long line. Before removing the line, the dog must demonstrate a stop (down, sit or stand) and a recall. Once the dog has completed this exercise, the line may be dropped for the dog to drag, or removed entirely. If the dog cannot exhibit the stop, the tester is not to allow the dog off-line.

Once the dog is allowed to approach the livestock, the tester will be looking for sustained interest in controlling the livestock. This can be shown by the dog gathering the livestock, moving the livestock toward the handler, or moving them ahead of the handler in a driving position. A combination of any of these styles is acceptable.

Belgian Sheepdog Club of America Herding Instinct Certificate

A Herding Instinct Certificate is being offered by the Belgian Sheepdog Club of America. In order to receive the Certificate, the dog must enter and pass one of the two offered Herding Instinct Tests offered at this event.* Pre-entry is recommended due to judge limitations.

Day-of-show entries will be accepted for Herding Instinct Testing if numerical limits have not been reached. Entries must be received by the Trial Secretary by 11:00 a.m.

Please fill out the "BSCA Herding Instinct Application" form and enclose it with your AKC entry form. While entering the AKC Instinct Test is not required, you get both for the same entry fee.:)

* To receive the AKC Herding Instinct Test (HIT) Certificate, the dog must pass under two separate judges.

Herding Test

The dog must be under control and demonstrate controlled movement of the stock from the first pylon to the second pylon, turn the stock at or near the second pylon, and move the stock back to the first pylon, where they are again turned (at or near the pylon) and moved back to the second pylon. At the handler's option, the dog may work the stock across the open arena or along the fence line. The test is concluded at or near the second pylon with a stop followed by a recall. The Judge indicates completion of the test, and the handler leashes the dog and leaves the arena. The five elements of the test, which must be executed are:

- 1. A controlled pause or stop at the beginning,
- 2 and 3. Two changes in direction at or near the proper pylon while exhibiting controlled movement of the stock.
- 4. A stop,
- 5. Followed by a recall at the conclusion of the run.
