### Notice to Exhibitors

Facility Information:

- There are three porta-johns on the property that will be serviced prior to the event. One in the parking area, the other two behind the dumpster (follow the power lines up the driveway). Hand sanitizer will be available.
- $_{\odot}$   $\,$  There will be no food service offered. Please plan to bring your own lunch, water, ice, etc.
- Event will be held rain or shine, we only stop for lighting and hail.
- Bitches in season shall be eligible and will be run in order in the trial classes and will be run at the end of their class in test classes.
- Every effort has been made to resolve conflicts, however, if your dogs are too close for comfort, please see the scribe at the beginning of the class about moving your dog.
- PARKING: Please follow all parking signs. Cars may not block the driveway or any gates.
- All dogs present which are not being worked in the arena must be kept quiet, off course, on leash and away from the fences. Do not allow them to disturb the resting stock or interfere with the working dog.
- PLEASE NOTE: Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

### **Emergency Information**

#### After Hours Emergency Animal Clinic

Valley Emergency Veterinary Clinic, 146 Garber Lane, Winchester, VA 22601

Directions To Valley Emergency Veterinary Clinic: Turn right on Va-7 W for 5.7 miles. Merge onto I-81 S. toward Roanoke (2.2 miles), merge onto US-17S/US-50E/US-522 via Exit 313A (0.3 miles). Turn right onto Front Royal Pike/US 522 (0.3 miles). Turn right onto Garber Road.

### Directions

Keepstone Farm is located at 412 Russell Road, at Keepstone Farm in scenic Berryville, Virginia; less than a mile from Route 7 West. It is easily accessible from Northern Virginia, West Virginia and Frederick Maryland via major roadways.

From the East: From Leesburg VA, take Route 7 West. Passing 2 traffic lights after the Rt 340 exit for Berryville, turn Right on Russell Road (Rt 660).

\* Go 3/10 mile, turn Right at large Keepstone Farm sign (Dog Gone Healthy sign below). Follow farm lane to Left turn at #412, and go to end of Driveway.

<u>From the West</u>: From I-81, Take Exit 315, Rt 7 East at Winchester VA. Go about 6 miles, and turn Left on Russell Road (Rt 660). Follow \* directions above.

<u>From the North</u>: From Frederick MD, take Rt 340/15 South, bearing right on 340 South at the split. Follow 340 to Charles Town WV, and continue South on 340 to Rt 7 West at Berryville VA. Follow Rt 7 West through 2 traffic lights, to Russell Rd on right. Follow \* directions above.

<u>From the South</u>: From Rt 66 West - Take Rt 17 North toward Paris VA. Take 17 to traffic light, and turn Left onto Rt 50 West toward Winchester. Follow Rt 50 W to a Right turn at Rt 340 North. (Sheetz Station at light). After going through the towns of Boyce and Berryville, turn Left onto Rt 7 West. Follow \* directions above.

# Day of Show Entries

Day of show entries will be allowed up to the course/stock/judge limits, and will be accepted up until the time listed on the below schedules for each trial.

Day of show entries are \$60 per entry. Make checks payable in US funds to: Clantyre Show Secretary, or visit <u>www.clantyre.net</u> to pay via PayPal.

Each entry will be on the approved form below, fully signed with all relevant dog information, class information, and release forms included.

## Tracking Number Policy

All dogs participating in AHBA events must have full information, including a registration number, provided for entry on recording forms. The registration number to be used should be the dog's regular registration number (AKC, CKC, ASCA, etc.). In the case of dogs which have more than one registration number, the owner must choose one and use it consistently for AHBA purposes. Owners of unregistered dogs may apply to the AHBA for a tracking number to be used in place of a registration number. This tracking number is only for dogs which are not otherwise registered. The form for requesting the tracking number is on the Forms page or may be obtained from Nancy Runyon by email at: rerunyon@aol.com, or regular mail: 1285 Hopewell Road, Harrodsburg, KY 40330-9181. The completed tracking number form is sent to the email or mailing address on the form, and the owner will be sent a tracking number to use for entering AHBA events. In addition to using a consistent registration or tracking number, owners must use one consistent name when entering a dog. An incomplete recording form received by the AHBA will not be processed.
