### Which Test Do I Enter?

## Herding Instinct Test\*

The Instinct Test is held in a small pen, either round in shape or with rounded corners, which can vary in size from  $50 \times 50$  feet, up to  $100 \times 100$  feet. Livestock used can be cattle, sheep or ducks. The dog will enter the pen on a 6-15 foot long line. Before removing the line, the dog must demonstrate a stop (down, sit or stand) and a recall. Once the dog has completed this exercise, the line may be dropped for the dog to drag, or removed entirely. If the dog cannot exhibit the stop, the tester is not to allow the dog off-line.

Once the dog is allowed to approach the livestock, the tester will be looking for sustained interest in controlling the livestock. This can be shown by the dog gathering the livestock, moving the livestock toward the handler, or moving them ahead of the handler in a driving position. A combination of any of these styles is acceptable.

\*The BCCA offers a Herding Instinct Certificate (HIC) to any Bearded Collie that passes the AKC Herding Instinct Test. Forms will be available at the Secretary's Table. Be sure and pick one up before your test. The owner needs to send form, \$3.00, and a copy of the AKC registration or ILP/PAL number to:

## Herding Test

The dog must be under control and demonstrate controlled movement of the stock from the first pylon to the second pylon, turn the stock at or near the second pylon, and move the stock back to the first pylon, where they are again turned (at or near the pylon) and moved back to the second pylon. At the handler's option, the dog may work the stock across the open arena or along the fence line. The test is concluded at or near the second pylon with a stop followed by a recall. The Judge indicates completion of the test, and the handler leashes the dog and leaves the arena. The five elements of the test, which must be executed are:

- 1. A controlled pause or stop at the beginning, 2 and 3. Two changes in direction at or near the proper pylon while exhibiting controlled movement of the stock,
- 4. A stop.
- 5. Followed by a recall at the conclusion of the run.

### Pre-Trial Test

The Pre-Trial Test is designed to help guide owners into a knowledge of, and participation in, herding activities, and will provide a dog that, while not fully refined by training, is demonstrably capable of performing herding work at a level just below the beginning trial level.

Full description of all classes is available in the AKC Herding Regulations, available for download: http://www.akc.org/rules

### Notice to Exhibitors

- Bitches in season shall be eligible and will be run at the end of their level in tests, in catalog order at the trial level.
- There will be no smoking at the show site. Please dispose of trash in the proper manner. Bring shade, water and chair. Event will be held rain or shine.
- All dogs present which are not being worked in the arena must be kept quiet, off course, on leash and away from the fences. Please do not allow them to disturb the resting stock or interfere with the working dog.
- Judges are not required to wait for dogs. It is the responsibility of the owner/handler to have the
  dog at ringside when required and without being called.
- Exhibition Only Day-of entries will be offered if entries have not reached the numerical limits and must be received by the trial secretary by 8:00 a.m.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The host club, Clantyre Show Secretary Services and its agents, employees, etc. will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

#### Closing of Entries/Alternates and Move-Ups

(AKC Herding Rules & Regulations, Section 13):

- Whenever trial entry limits have been reached all additional entries that are received prior to the closing date shall be added to an alternate's list for each level that exceeds the published limit(s). This trial will keep an alternate list of five (5) runs per stock/course.
- Entrants on the alternates list must check in with the Herding Secretary on the grounds no later than 30 minutes before the commencement of their class.
- Entry fee will be refunded to the alternates whose dogs do not have an opportunity to run.
- Requests for move-up must be given to the Herding Secretary at least 30 minutes prior to the start of the event.

#### **Refund Policy**

- 1. Entry fees will not be refunded in the event that a dog is absent, disqualified, or excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee.
- If because of riots, civil disturbances, or other acts beyond the control of the show giving club, it is impossible to open or complete the show, no refunds will be made.
- Refunds of entries pulled after closing date will be made as long as an alternate is available to replace the run; if no alternate runs, no refund will be given.
- 4. No refund for duplicate entries or any other cause beyond the control of the BCCA after the closing date (Rules Applying to Dog Shows, Chapter 11, Section 6) including injured or sick dogs or handlers. In the event of a spouse, sibling, parent or entered dog's untimely death, an event committee decision will be made.
- 5. Declination of entries: The BCCA may decline any entries for cause and may remove any dog on account of disease, viciousness, or other cause and no one shall have any claim or recourse against the BCCA or any official thereof. In this case, no refund will be made.

## Eligibility of Dogs

Open to all herding breeds nine (9) months of age or older that are registered with The American Kennel Club or have been granted an ILP\PAL and are eligible to compete in herding trials and tests under Chapter 1, Section 3 of the AKC Herding Regulations.

Dogs may enter the Instinct Test at six (6) months of age or older.
