Closing of Entries/Alternates and Move-Ups

- When trial entry limits have been reached, all additional entries received prior to the closing date will be added to a wait list. At closing, two alternates per trial will be chosen by the trial secretary from the wait list, with preference given to dogs/handlers who are expected to be on the grounds the day of the trial. All other wait-listed entries will be returned.
- Entrants on the alternates list must check in with the Herding Secretary on the grounds no later than 30 minutes before the commencement of their class.
- Entry fee will be refunded to the alternates whose dogs <u>do not</u> have an opportunity to run. Alternates must run in their respective levels if present and if provided with the opportunity to run.
- Requests for move-up must be given to the Herding Secretary at least 30 minutes prior to the start of the event.

Refund Policy
