# NOTICE TO EXHIBITORS

- All judging will be outdoors, bring your own shade, water will be available. The trial will be held rain or shine. Dress for the weather and bring chairs.
- Please pick up after your dog. Clean-up supplies will be available. You are requested to clean up and leave the test site and grounds as we received them.
- All dogs present which are not being worked in the arena must be kept quiet, off course, on leash and away from the fences. Please do not allow them to disturb the resting stock or interfere with the working dogs.
- The judge is not required to wait for dogs. It is the responsibility of the owner or handler to have the dog at ringside when required and without being called.
- All class prizes will be awarded in the ring when judging of that class is over. Special prizes will be awarded at the end of regular classes. None will be mailed.
- · While flexi-leads are not prohibited, responsible use is expected.
- Food will not be available at the show site, please bring your own.
- Bitches in season shall be eligible to run and will run at the end of the class in tests and in catalog order as listed in the class in trials.
- Exhibition Only Day-of entries will be offered if entries have not reached the numerical limits and must be received by the test secretary by 8:00 a.m.

#### **MOVE-UPS**

Requests to move up must be given to the Herding Secretary at least 30 minutes prior to the start of the event.

# **RUNNING ORDER**

Running order is as listed, with the first handlers' meeting occurring no earlier than the posted time. Judging will begin immediately after the handlers' meeting. All exhibitors should check in with the Trial Secretary at least thirty (30) minutes before their class begins.

# There will be a separate handlers' meeting held for each class before it begins.

# DIRECTIONS

Keepstone Farm is located at 412 Russell Road, at Keepstone Farm in scenic Berryville, Virginia; less than a mile from Route 7 West. It is easily accessible from Northern Virginia, West Virginia and Frederick Maryland via major roadways.

From the East: From Leesburg VA, take Route 7 West. Passing 2 traffic lights after the Rt 340 exit for Berryville, turn Right on Russell Road (Rt 660).

\* Go 3/10 mile, turn Right at large Keepstone Farm sign (Dog Gone Healthy sign below). Follow farm lane to Left turn at #412, and go to end of Driveway.

From the West: From I-81, Take Exit 315, Rt 7 East at Winchester VA. Go about 6 miles, and turn Left on Russell Road (Rt 660). Follow \* directions above.

From the North: From Frederick MD, take Rt 340/15 South, bearing right on 340 South at the split. Follow 340 to Charles Town WV, and continue South on 340 to Rt 7 West at Berryville VA. Follow Rt 7 West through 2 traffic lights, to Russell Rd on right. Follow \* directions above.

From the South: From Rt 66 West - Take Rt 17 North toward Paris VA. Take 17 to traffic light, and turn Left onto Rt 50 West toward Winchester. Follow Rt 50 W to a Right turn at Rt 340 North. (Sheetz Station at light). After going through the towns of Boyce and Berryville, turn Left onto Rt 7 West. Follow \* directions above.
