- ❖ Drawing for **run order** shall be held at 5474 Delphinium Court, Columbia, MD 21045 on Friday, July 10, 2009 at 7:00 p.m.
- ❖ Make checks or money orders payable to **Shetland Sheepdog Club of Greater Baltimore (or SSCGB)**. All fees are payable in U.S. funds. Entry fee is \$50 for test classes. Each entry fee includes \$3.00 AKC recording fee.

Fax/Credit Card entries will be accepted up to the closing date and time. Official AKC entry forms must be used and both sides must be transmitted. A cover sheet must include: Cardholder's name, address, city, state and zip code, phone Number and e-mail address, Credit Card Number, type (**Visa or MasterCard**) and expiration date, a written signature on the cover letter authorizing payment of entry and fax fees, "CVV" Code (the last 3 numbers that appear in the signature area on the back of the card) and the total number of pages including the cover sheet. The fax fee is \$3.50 per dog. All entries using a credit card, regardless of method of submission, will be processed through the fax/credit card system and will be charged the fax fee. You may wish to call to confirm receipt of your fax, as proof of transmission is not proof of receipt (Phone: 410-997-3698).

- ❖ Telegraph, telephone and unsigned entries cannot be accepted. Entries not on an official AKC entry form and photocopies of entry forms without agreement and rules are NOT ACCEPTABLE. Entries received without fees will not be accepted. Acknowledgement of entries will be made as soon as practicable. Do not send entries requiring a signature upon delivery. Returned checks, postdated checks or declined credit cards do not constitute a valid entry fee. The Test Secretary will add a \$30 collection fee to the amount of each returned check.
- ❖ **PLEASE make your entries correct and legible.** Illegible entries cannot be processed and will be returned to the exhibitor. Owner/Exhibitors are responsible for errors on entry forms. (Rules Applying to Dog Shows, Chapter 11, Section 6).
- ❖ Entry fees will not be refunded in the event that a dog is absent, disqualified, or excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee. No refunds for bitches in season. If because of riots, civil disturbances, or other acts beyond the control of the show giving club, it is impossible to open or complete the show, no refunds will be made.
- ❖ Bitches in season shall be eligible and will run at the end of the class in tests.
- ❖ **Food** is not available at show site. There will be **no smoking** at the show site. Please dispose of trash in the proper manner.
- ❖ All dogs present which are not being worked in the arena must be kept quiet, off course, on leash and away from the fences. Please do not allow them to disturb the resting stock or interfere with the working dog.
- ❖ Declination of entries: The SSCGB may decline any entries for cause and may remove any dog on account of disease, viciousness, or other cause and no one shall claim or recourse against the SSCGB or any official thereof.
- ❖ Judges are not required to wait for dogs. It is the responsibility of the owner/handler to have the dog at ringside when required and without being called.
- ❖ Bring Shade, Water and Chair. Event will be held rain or shine.
- ❖ **Exhibition Only** will be offered if Test entries have not reached the numerical limits. Exhibition only Day-of entries will be accepted and must be received by the test secretary by 2:00 p.m.
- ❖ **Closing of Entries/Alternates and Move-Ups** (AKC Herding Rules & Regulations, Section 13):

Whenever test entry limits have been reached all additional entries that are received prior to the closing date shall be added to an alternate's list for each level that exceeds the published limit(s).

Entrants on the alternates list must check in with the Herding Secretary on the grounds no later than 30 minutes before the commencement of their class.

Requests to move-up must be given to the Herding Secretary at least 30 minutes prior to the start of the event.

DIRECTIONS

* Go 3/10 mile, turn Right at large Keepstone Farm sign (Dog Gone Healthy sign below). Follow farm lane to Left turn at # 412, and go to end of Driveway.

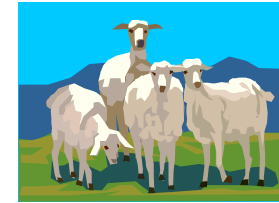
