Telegraph, telephone and unsigned entries cannot be accepted. Entries not on an official AKC entry form and photocopies of entry forms without agreement and rules on the reverse side of the official AKC entry form are NOT ACCEPTABLE.

Entries received without fees will not be accepted. Acknowledgement of entries will be made via email as soon as practicable. Please include legible e-mail address on your entry form.

**Do not send entries requiring a signature upon delivery.**

Returned checks do not constitute a valid entry fee. The Show Secretary will add a \$30 collection fee to the amount of each returned check. Entry fees will not be refunded in the event that a dog is absent, disqualified, or excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee. No refunds for bitches in season. If because of riots, civil disturbances, or other acts beyond the control of the show giving club, it is impossible to open or complete the show, no refunds will be made. Event Service Fees on herding events will be \$3.50 per entry. (*American Kennel Club Herding Regulations, Chapter 1, Section 16.*)

### Fax/Credit Card Entries

**Fax/Credit Card entries** will be accepted up to the closing date and time. Official AKC entry forms must be used and both sides must be transmitted. A cover sheet must include: Cardholder's name, address, city, state and zip code, phone Number and e-mail address, Credit Card Number, type (**Visa, MasterCard or Discover**) and expiration date, a written signature on the cover letter authorizing payment of entry and fax fees, "CVV" Code (the last 3 numbers that appear in the signature area on the back of the card) and the total number of pages including the cover sheet. The fax fee is \$4.00 per dog. All entries using a credit card, regardless of method of submission, will be processed through the fax/credit card system and will be charged the fax fee. # What Do I Enter?

## Herding Instinct Test

The Instinct Test is held in a small pen, either round in shape or with rounded corners, which can vary in size from 50 x 50 feet, up to 100 x 100 feet. Livestock used can be cattle, sheep or ducks. The dog will enter the pen on a 6-15 foot long line. Before removing the line, the dog must demonstrate a stop (down, sit or stand) and a recall. Once the dog has completed this exercise, the line may be dropped for the dog to drag, or removed entirely. If the dog cannot exhibit the stop, the tester is not to allow the dog off-line.

Once the dog is allowed to approach the livestock, the tester will be looking for sustained interest in controlling the livestock. This can be shown by the dog gathering the livestock, moving the livestock toward the handler, or moving them ahead of the handler in a driving position. A combination of any of these styles is acceptable.

\* To receive the HIT Certificate, the dog must pass under two separate judges.

## Herding Test

The dog must be under control and demonstrate controlled movement of the stock from the first pylon to the second pylon, turn the stock at or near the second pylon, and move the stock back to the first pylon, where they are again turned (at or near the pylon) and moved back to the second pylon. At the handler's option, the dog may work the stock across the open arena or along the fence line. The test is concluded at or near the second pylon with a stop followed by a recall. The Judge indicates completion of the test, and the handler leashes the dog and leaves the arena. The five elements of the test, which must be executed are:

1. A controlled pause or stop at the beginning,
- 2 and 3. Two changes in direction at or near the proper pylon while exhibiting controlled movement of the stock,
4. A stop,
5. Followed by a recall at the conclusion of the run.

# Notice to Exhibitors

- Bitches in season shall be eligible and will be run at the end of their class.
- There will be no smoking at the show site. Please dispose of trash in the proper manner. Bring shade, water and chair. Event will be held rain or shine.
- All dogs present which are not being worked in the arena must be kept quiet, off course, on leash and away from the fences. Please do not allow them to disturb the resting stock or interfere with the working dog.
- Judges are not required to wait for dogs. It is the responsibility of the owner/handler to have the dog at ringside when required and without being called.
- Day-of-show entries will be offered for herding instinct testing if entries have not reached the numerical limits and must be received by the trial secretary by 11:00 a.m.

## Refund Policy

1. Entry fees will not be refunded in the event that a dog is absent, disqualified, or excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee.
2. If because of riots, civil disturbances, or other acts beyond the control of the show giving club, it is impossible to open or complete the show, no refunds will be made.
3. Refunds of entries pulled after closing date will be made as long as an alternate is available to replace the run; if no alternate runs, no refund will be given.
4. No refund for duplicate entries or any other cause beyond the control of the SSCGB after the closing date (Rules Applying to Dog Shows, Chapter 11, Section 6) including injured or sick dogs or handlers. In the event of a spouse, sibling, parent or entered dog's untimely death, an event committee decision will be made.

## Directions

From the North: Take I-97 South off the Baltimore Beltway. Exit New Cut Road. Turn right at the end of the ramp. Follow approximately 1.5 mile to fork in road. Bear left onto Gambrills Rd. Go approx 2 miles to flashing red traffic light and turn left onto Dicus Mill Rd. Turn right at the second street, Ski Lane. After 3 houses, the main road turns left and the driveway to 470 continues straight ahead. Follow the signs to the far back of the property.

From the South: Take either 97 north or Rte 3 north to Rte 32 west. Exit Burns Crossing Road. At the end of a long ramp; turn right at the traffic light onto Burns Crossing. Take the first immediate street on the right, Dicus Mill. Go approx two miles to stop sign and flashing yellow light, continue straight and follow the directions above to Ski Lane.

From the West: Take Rte 32 east to Burns Crossing Road. Turn right at end of ramp. Right at first traffic light, then left at next light onto Burns Crossing. Turn right onto first immediate street, Dicus Mill and follow directions above.

From the East: Take Benfield Blvd west to four way stop sign; turn left onto Najoles Rd. After 1 mile Najoles turns abruptly right and changes names to Dicus Mill Rd. Continue approx 1.5 miles further to a left onto Ski Lane. Follow directions to site above.
