NOTICE TO EXHIBITORS

- All judging will be held indoors, on mats over concrete, with ring gating surrounding each ring. The obedience/rally area of the building has no heating or air-conditioning, but is well ventilated.
- Crating: The building will be open to set up crates for both trials starting at 7:00 a.m. on Wednesday, October 5. Crates may be left in the building overnight, but must be removed at the close of the trial on Thursday, October 7. No ex-pens or grooming tables allowed inside the building.
- No dogs under six (6) months of age on show grounds. All dogs present must be on leash or confined to their crates except when being judged.
- NO flexi-leads in the building.
- Food is available on site. There will be no smoking in the building.
- Please dispose of trash in the proper manner. All persons are responsible for picking up after their dogs. Anyone not picking up after their dog will be asked to leave the show grounds. NO EXCEPTIONS!
- Free admission/Free parking. All Fire Lanes must be kept clear at all times. Vehicles left in Fire Lanes will be towed at the owner's expense.
- The judge is not required to wait for dogs. Each handler is responsible for being ready at ringside when required and without being called.
- Conflicts: We will try our best to accommodate agility conflicts, although we offer no guarantee that we can resolve them all. You can help by notifying the Obedience/Rally staff as soon as possible regarding potential conflicts.
- Jump Height: Dogs will be placed in "small to tall" jump height order in both Obedience AND Rally.
- ❖ Catalogs: A limited number will be available at the show for \$8.00.
- Bitches in season are not permitted to compete in Obedience/Rally trials. The Club will refund the entry fees for bitches unable to compete for that reason upon presentation of a signed note (on official business letterhead) from a veterinarian stating that the bitch is in season. The note must be presented to the Trial Secretary by the end of the trial on Thursday, October 7.
- Obedience and Rally move-ups will be permitted in accordance with Obedience Regulations, Chapter 1, Section 16. The request for a move-up must be in writing and presented to the trial secretary at least 30 minutes prior to the start of the trial.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
