*Walkthroughs for A & B within classes will be combined (Rally Excellent, Advanced and Novice. Beginner Novice A & B walkthrough will also be combined). Due to COVID-19 precautions, walkthroughs may be split at the judge's discretion. Class judging will immediately follow the walkthrough in the order listed.

IMPORTANT "COVID-19" TRIAL INFORMATION



Please read!

Things you can expect on trial days:

- Everyone entering the building will be required to sign a release (see next page).
- **NOTE: Please print, sign and date the waiver and present it when you check in. It should be signed/dated on the day of the trial. Waivers sent in with entry forms are not valid.**
- Exhibitors may be asked to submit to a non-contact temperature check.
- There will be **no** indoor crating for exhibitors. Please come prepared to work from your car.
- Spectators will not be allowed in the building. Traffic flow in and out of the building will be clearly marked.
- Masks will be required to enter the building. Exhibitors are expected to bring masks, they will not be supplied. You will be required to wear a mask when in the ring.
- Parking: Leave some "social space" between cars when parking, expect to work from your car. RV Parking will not be available.
- Social distancing will remain in effect.
- Paper course maps will not be available. Course maps will be displayed in several places. Come prepared to photograph the map for your personal use.
- Check-in and armband pick-up area will be clearly marked.
- Food will not be available onsite. Plan on bringing your own lunch, water, drinks, ice, etc.
- Briefings/walkthroughs: Expect distance briefings, smaller walkthroughs.
- Exhibitors are expected to follow state, local government, event and facility guidelines.
- **ARRIVAL TIMES: Please do not arrive more than 30 minutes prior to your class start time. You will not be permitted access to the building.**
- **WARMUP: Each dog/handler team will be permitted into the building 10 minutes prior to their run to warm up.**

NOTICE TO EXHIBITORS

- All judging will be indoors.
- **Crating:** There will be no indoor crating for exhibitors. Please come prepared to work from your car. (*Exceptions are Trial Chair, Trial Secretary and All-Day Volunteers, with express permission of the Trial Chair.*)
- Free admission / Free parking.
- Food will not be available onsite. Plan on bringing your own lunch, water, drinks, ice, etc.
- **REFUND POLICY:**
Bitches in season are not permitted to compete in obedience trials. The club will refund all but \$10.00 of the entry fee for bitches in season that are unable to compete for that reason. Refund requests must be accompanied by a dated, signed letter on official business letterhead from your veterinarian stating the reason that your dog cannot compete. The Trial Secretary must be notified no later than one half hour prior to the start of the first class in the trial.
E-mails, phone calls and non-letterhead notes will not be considered. There will be no refund for injury or illness after entries close.
- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Show Committee deems the exhibitor to be in violation of this requirement. No dogs under 4 months of age on show grounds. There will be no smoking in the building. Please dispose of all trash in the proper manner.
- The judge is not required to wait for dogs. It is the responsibility of the owner/handler to have the dog at ringside when required and without being called. All dogs present must be held on a leash, or confined to a crate except when being judged.
- Exhibitors should follow their veterinarians recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The host club, Up Front Dog Training Center, Clantyre Show Secretary Services and its agents, employees, etc. will assume no responsibility for any loss, damage, illness or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.
- If you wish a catalog, they **MUST** be pre-ordered by October 28 at a cost of \$5.00. Catalogs will not be for sale at the site.

Most GPS devices will get you there, make sure you see the flag on the driveway

From NJ Turnpike exit 7A: Take I-195 East to Route 526. Make a Right on Route 526 to Main Street. Make a Right on Main St. to Route 539. Make a Left on Route 539 to Arneytown-Hornerstown Road. Make a Right on Arneytown-Hornerstown Road.

From NJ Turnpike exit 7 and from Rt. 295, exit 57: Take Rte 206 North to Route 528 (Crosswicks Road). Make a Right on Rte 528; travel approx. 6 miles. Pass through one roundabout and stay straight. Do NOT turn right. Stay straight (bear left at Chesterfield Inn) to go onto Arneytown-Chesterfield Rd / County Hwy 664. (Road is now Route 664). When you see a corner house with weathervanes, turn right to stay on Rte 664. Continue for approximately 2 miles. Turn left onto Arneytown- Hornerstown Road. Go about ½ mile to Up Front driveway on left. A blue flag with a white dog will be in front.

From Freehold: Start out going southwest on W Main St/County Hwy-537 toward Throckmorton St/County Hwy-522. Continue to follow County Hwy-537. Follow Route 537 West. Turn Right on Route 539. Turn Left on Arneytown-Hornerstown Rd. Go approximately 0.49 mile on your left. A blue flag will be in front with the name Upfront Dog Center

From Mount Holly: Follow Route 537 East. Turn Left on Route 539. Turn Left on Arneytown-Hornerstown Road. A blue flag will be in front with the name Upfront Dog Center.

TRAFFIC NOTE: Please allow extra 15 minutes for travel time due to ongoing construction on Route 528.
