# Notice to Exhibitors

- **MOST IMPORTANT: If you are exhibiting signs of illness, have tested positive or have been otherwise told to self-quarantine due to known Covid-19 exposure, please stay home.**
- All judging will be indoors.
- The building will open Friday at 4:00 PM, Saturday and Sunday at 7:30 AM.
- CRATING: As of the publishing of this judging schedule, crating will be allowed in the building. No ex-pens. No unentered dogs or dogs under 4 months of age in the building. Crate set-up will not be available prior to 4:00 PM on Friday.
- As of the publishing of this judging schedule, mask wear in the building is optional. If this policy changes, signs will be posted at the site and announcements made. Please come prepared with your own mask just in case, none will be provided. Exhibitors are expected to follow state, local government, event and facility guidelines.
- Rally paper course maps will not be available. Course maps will be posted. Come prepared to photograph the map(s) for your personal use.
- TRANSFERS:
  - Obedience transfers will be permitted in accordance with Obedience Regulations, Chapter 1, Section 16. The request for a transfer must be in writing and presented to the Trial Secretary at least 30 minutes prior to the start of each trial. Transfers may be approved provided the next level class and judges are available and the class has not reached its limit.
  - Rally transfers will be permitted in accordance with Rally Regulations, Chapter 1, Section 13. The request for a transfer must be in writing and presented to the Trial Secretary at least 30 minutes prior to the start of each rally trial.
- Obedience and Rally classes will run in jump height order from “small—tall.”
- Food will not be available onsite. Plan on bringing your own lunch, drinks, etc. Fast food is available within 2 miles of the site.
- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Show Committee deems the exhibitor to be in violation of this requirement. There will be no smoking in the building. Please dispose of all trash in the proper manner.
- The judge is not required to wait for dogs. It is the responsibility of the owner/handler to have the dog at ringside when required and without being called. All dogs present must be held on a leash, or confined to a crate except when being judged.
- Waiver of Rights – Animals in Distress: All persons attending these dog shows waive any claim for damages should Capital Dog Training Club have to take action to remove an animal in distress from a parked vehicle or crate.



# Directions

## From I-495 / I-95

From I-495/95, use Exit 23 (Route 201 – Kenilworth Avenue). Go north 4.2 miles to Distribution Drive, turn left. Note that Route 201 starts as Kenilworth Avenue, changes to Edmonston Road and then to Old Baltimore Pike. \*

## From I-95 (South or North)

From I-95 South or North, take Exit 29A – Powder Mill Road (changes to Ammendale Road at light). Go to Virginia Manor Road, turn left. At light at Murkirk Road, turn right. At light at Old Baltimore Pike, turn right. \* Follow Old Baltimore Pike to Distribution Road and turn right at Shepherds Electric Company. 6822/6828 Distribution Drive is on right past after a curve to the left.
