# Robert J. Squires

In 1966, after returning from 13 months in Vietnam, and moving to Camp Lejeune, NC, Bob decided to buy a dog. Like many people, he knew nothing about dogs but got lucky with his first German Shepherd. Knowing he should train the dog, he signed up for an obedience training class. Fortunately for Bob, and the dog, the instructor was tremendous. After about 8 weeks of training, he entered his first obedience trial, (there were no matches in the area). In just under 9 months, the dog earned a UD. As Bob soon found out, after training and entering additional dogs, his first dog was especially easy to train.

After a second 13 month tour in Vietnam, Bob ended up in Quantico, VA, and became very active in training. His second German Shepherd and a Miniature Poodle completed their UD's. W hile at Quantico, Bob became one of the founding members of the Marumsco Dog Training Club, serving as Training Director and President. He was also member of the Mattaponi Kennel Club.

From 1969-1970, Bob began judging matches and was approved to judge Novice in the early 1970's. Around 1975 he was approved to judge Open. Unfortunately, he had little time to judge, as he was transferred to Okinawa, Japan for four years. About a year before moving to Okinawa, Bob purchased his first Doberman and trained her through Utility. - All judging will be indoors.
- Crating space is limited, so plan on getting cozy with your neighbor and sharing where you
  can. Crate set-up time will be available on Thursday night from 6:00 PM until the conclusion of
  the Rallv "C" Match.
- Transfers will be permitted in accordance with Obedience Regulations, Chapter 1, Section 16.
   The request for a transfer must be in writing and presented to the Trial Secretary at least 30 minutes prior to the start of the trial.
- The Rally ring is 40 x 50 feet. The Friday Rally trials will run concurrently but will have staggered start times. Judging times will be scheduled to minimize conflicts for exhibitors who enter both trials and to allow time for transfers from Trial 1 to Trial 2.:)
- A wait-list will be established in order to fill openings created by entries that are withdrawn prior to the event closing day.
- Obedience and Rally classes will run in jump height order from "small—tall." Your jump height must be included on the entry form for all classes that require a jump.
- Club members will be providing a pot luck luncheon for the judges and workers. Exhibitors
