Notice to Exhibitors

- All judging will be indoors.
- Transfers will be permitted in accordance with Rally Regulations, Chapter 1, Section 15. The request for a transfer must be in writing and presented to the Trial Secretary at least 30 minutes prior to the start of the trial. Transfers will be accepted prior to the day of the trial. Requests should be emailed to: showsec@clantyre.net or mailed to: Clantyre Show Secretary Services, 5474 Delphinium Ct., Columbia, MD 21045.
- The Rally ring will be a minimum of 40 x 50 feet. The Rally trials will run consecutively.
- Rally classes will be run in "small-tall" height order.
- Food will not be available onsite. Plan on bringing your own lunch, water, drinks, ice, etc.
- **REFUND POLICY:**
Bitches in season are not permitted to compete in obedience trials. The club will refund all but \$10.00 of the entry fee for bitches in season that are unable to compete for that reason. Refund requests must be accompanied by a dated, signed letter on official business letterhead from your veterinarian stating the reason that your dog cannot compete. The Trial Secretary must be notified no later than one half hour prior to the start of the first class in the trial. E-mails, phone calls and non-letterhead notes will not be considered.
- Exhibitors and handlers will be responsible for clean conditions in and around their crating area. There is no space for un-entered dogs.
- The judge is not required to wait for dogs. It is the responsibility of the owner/handler to have the dog at ringside when required and without being called. All dogs present must be held on a leash, or confined to a crate except when being judged.
- Exhibitors should follow their veterinarians recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The host club, Clantyre Show Secretary Services and its agents, employees, etc. will assume no responsibility for any loss, damage, illness or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

Waiver of Rights – Animals in Distress

Catoctin Kennel Club reserves the right to contact appropriate authorities to remove any animal in distress from a parked vehicle and all persons attending these dog events hereby waive any claim for damages against the clubs for such removal. The Club regards the health, safety and life of any dog on the show grounds to be paramount to other property or privacy rights. From I-70: Take US 340W & US 15 South from Frederick towards Leesburg & Harpers Ferry; take US 15 South to Point Of Rocks/MD Route 28 (flashing yellow light immediately before Potomac River Bridge); turn left onto Route 28 and go approximately 1 mile and turn right onto Rock Hall Rd. (immediately after RR); site is one story building on left.

From Washington I-270: follow signs for Route 340 to Route 15 South and follow as above.

From the West: From Leesburg, follow US 15 North, immediately after crossing the Potomac River Bridge, turn right onto Route 28 in Point of Rocks. Turn Right on Rock Hall Rd., just after crossing the railroad tracks. Turn left into the parking lot.
