Important Information for All Trials



A walk-through (for handlers without their dogs) will take place prior to Rally classes, Obedience Novice A, Beginner Novice, and Preferred Novice classes. Walkthroughs may be combined or split at the judge's discretion. Class judging will immediately follow the walkthrough in the order listed.

If the published judge and ring are available prior to the listed start time and all exhibitors have checked in and agree, the judge may start a class earlier than the class time listed.

Judges will take a luncheon break at their discretion, which may impact start times.

Notice to Exhibitors

- All judging will be indoors.
- The building will open one hour prior to the start of judging each day.
- Transfers will be permitted in accordance with Obedience Regulations, Chapter 1, Section 16 and Rally Regulations, Chapter 1, Section 15. The request for a transfer must be in writing and presented to the Trial Secretary at least 30 minutes prior to the start of the trial. Transfers will be accepted prior to the day of the trial. - Indoor crating will be allowed.
- The judge is not required to wait for dogs. It is the responsibility of the owner/handler to have the dog at ringside when required and without being called. All dogs present must be held on a leash, or confined to a crate except when being judged.
- There will be no smoking in the building. Please dispose of trash in the proper manner.
- Exhibitors should follow their veterinarians recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- For your convenience, totals have been carefully tabulated. Neither the Club nor the Show Secretary assumes responsibility for absolute accuracy.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The host club, Clantyre Show Secretary Services and its agents, employees, etc. will assume no responsibility for any loss, damage, illness or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

From I-70: Take US 340W & US 15 South from Frederick towards Leesburg & Harpers Ferry; take US 15 South to Point Of Rocks/MD Route 28 (flashing yellow light immediately before Potomac River Bridge); turn left onto Route 28 and go approximately 1 mile and turn right onto Rock Hall Road (immediately after RR tracks); site is one story building on left.

From Washington I-270: Follow signs for Route 340 to Route 15 South and follow as above.

From the West: From Leesburg, follow US 15 North, immediately after crossing the Potomac River Bridge, turn right onto Route 28 in Point of Rocks. Turn Right on Rock Hall Rd., just after crossing the railroad tracks. Turn left into the parking lot.
