Directions to the Trial Site

From 95 North: Take Exit 50A-50B onto Caton Ave toward South Washington. Keep right onto Caton Ave. S toward Washington Blvd. Turn right onto Joh Ave. Turn left on-to Benson Ave. Turn left onto Knecht Ave. Turn left onto Azar Ct, #9 is on the right.

From Interstate 695/Baltimore Beltway traveling towards Essex: Take Exit 11A-11B for Interstate 95 South towards Washington. Keep right and follow signs for Sulphur Springs Rd. Turn right onto Sulphur Springs Rd. (signs say Arbutus/Violetville). Take the first right onto Benson Ave. Take a right onto Knecht Ave. Turn left onto Azar Ct, #9 is on the right.

From Interstate 695/Baltimore Beltway traveling towards Towson: Take Exit 10 for US-1 ALT/ Washington Blvd in Halethorpe. Turn left onto Rt 1, turn right onto Sulphur Springs Rd. Take the first right onto Benson Ave. Take a right onto Knecht Ave. Turn left onto Azar Ct, #9 is on the right.

* Rally times listed are the earliest possible time that the walk-through, followed by judging for that class will begin. Transfers for the Excellent and Advanced classes will be placed in jump-height order. Walkthroughs may be combined at the judge's discretion.

**Walkthrough: A walkthrough of up to 10 minutes (for handlers without their dogs) will take place prior to the start of the Novice A, Beginner Novice A & B classes. Beginner Novice A & B walkthroughs may be combined at the discretion of the judge.

Judges will take a luncheon break at their discretion.

Notice To Exhibitors

All judging will be indoors.

Flooring Restructions:

A waterproof pad is required under all crates.

Only WATER is allowed on the turf flooring—no other type of beverage.

Crumbly dog treats are not allowed on the turf flooring. Soft dog treats are allowed.

Food, gum and drinks other than water will not be allowed on the field turf flooring.

Food will not be available at the show site. Please plan on packing your lunch. Fast food is available nearby.

Obedience transfers will be permitted in accordance with Obedience Regulations, Chapter 1, Section 16. The request for a transfer must be in writing and presented to the trial secretary at least 30 minutes prior to the start of the trial.

There is plenty of crating space available. No ex-pens. No unentered dogs, please. No dogs under 4 months of age on show grounds. All dogs present must be on leash or confined to their crates except when being judged.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Show Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

There will be no smoking in the building. Please dispose of trash in the proper manner.

The judge is not required to wait for dogs. Each handler is responsible for being ready at ringside when required and without being called.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The host club, Clantyre Show Secretary Services and its agents, employees, etc. will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

All persons attending this dog show/event, hereby waive any claim for damages against the Dog Owners' Training Club of Maryland, Inc. or its members, in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.
