Notice To Exhibitors

Indoor crating will be allowed. The building is large enough to maintain social distancing. The club will be marking 10' x 10' squares on the floor in the center of the arena for crating. Spaces will be plentiful and and are first come, first served. **There is plenty of crating space available.** No ex-pens. No unentered dogs, please. No dogs under 4 months of age on show grounds. All dogs present must be on leash or confined to their crates except when being judged.

Paper course maps will not be available. Course maps will be displayed in several places. Come prepared to photograph the map for your personal use.

Food will not be available onsite. Plan on bringing your own lunch, water, drinks, ice, etc. Fast food is available within 2 miles.

Briefings/walkthroughs: Expect distance briefings, smaller walkthroughs.

All judging will be indoors.

The building will be open to judges and volunteers at 6:30 AM, open to exhibitors at 7:00 AM.

Transfers: Obedience & Rally transfers will be permitted in accordance with Obedience Regulations, Chapter 1, Section 16 and Rally Regulations, Chapter 1, Section 15. The request for a transfer must be in writing and presented to the trial secretary at least 30 minutes prior to the start of the trial. Transfer forms will be available at the Secretary Table. **Rally transfers between trials will not be accepted, as the trials are running concurrently.**

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Show Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

There will be no smoking in the building. Please dispose of trash in the proper manner.

The judge is not required to wait for dogs. Each handler is responsible for being ready at ringside when required and without being called.

Exhibitors should follow their veterinarians recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The host club, Clantyre Show Secretary Services and its agents, employees, etc. will assume no responsibility for any loss, damage, illness or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

All persons attending this dog show/event, hereby waive any claim for damages against the Dog Owners' Training Club of Maryland, Inc. or its members, in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.

Directions to the Trial Site

From the North, East, or South:

Follow I-695 (Baltimore Beltway) to Exit 19 (I-795) towards Owings Mills/Reisterstown continuing until the expressway ends. Bear right onto Route 140 West (towards Westminster) continuing for 10.9 miles to the light at Center Street. Turn left at the light onto Center Street. Proceed 1.6 miles through a four-way stop sign and two traffic lights. Go past the Farm Museum on the right and Carroll Hospital on the left and you will be at the stop sign at Gist Road. Turn right onto Gist Road. Drive 0.1 miles and turn right onto Aq Center drive.

From the East or South - Alternate route (more back road driving):

Take Route 32 West (to Sykesville/Westminster). Turn left on Kate Wagner Road. Turn right onto Gist Road. After you pass Smith Ave turn left onto Aq Center drive.

From the West:

From I- 70 Exit 68 – Route 27 North to right onto Kate Wagner Rd. Turn left onto Gist Road and follow alternate route directions above.

From I-70 Exit 76 - Route 97 North to left on Hook Road. Turn right onto Gist Road and follow alternate route directions above.

From I-70 Exit 80 - Route 32 West. Left onto Kate Wagner Rd. Right onto Gist Road and follow alternate route directions above.
