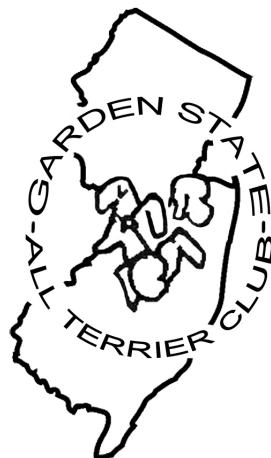

Notice To Exhibitors

All judging will be held indoors.

Dogs under 4 months of age are not permitted on the show grounds of AKC events.

All dogs present must be on leash or confined to their crates except when being judged. **NO Flexi-Leads** in the building.

Food will be available on show site. ☺

Crating: The building will be open to set up crates starting at 8:00 a.m.

There will be **no smoking** in the building. Please dispose of **trash** in the proper manner.

All persons are responsible for picking up after their dogs. Anyone not picking up after their dog will be asked to leave the show grounds. **NO EXCEPTIONS!**

The judge is not required to wait for dogs. Each handler is responsible for being ready at ringside when required and without being called.

A very limited number of catalogs will be available at the show for \$7.00.

Bitches in season are not permitted to compete in Obedience/Rally trials. The Club will refund all but \$5 of the entry fee for bitches unable to compete for that reason upon presentation of a signed note (on official business letterhead) from a veterinarian stating that the bitch is in season. The note must be presented to the Trial Secretary by the end of the trial on Wednesday, October 1.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The host club, Clantyre Show Secretary Services and its agents, employees, etc. will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

Obedience and Rally transfers will be permitted in accordance with Obedience Regulations, Chapter 1, Section 16. The request for a transfer must be in writing and presented to the trial secretary at least 30 minutes prior to the start of the trial.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Parking Rules

All Parking Rules will be enforced. Please maintain the cleanliness and order of assigned spots. No saving of spaces for others with cones or ex-pens. Reserving additional space by any means will result in an additional fee.

Anyone parking in an area other than one assigned by the Parking Committee/Site Control will be subject to immediate removal from the Show Site at their expense and held financially responsible for any and all cost for damages caused to the grounds. **THE BASEBALL FIELDS ARE STRICTLY A NO PARKING ZONE -- KEEP OFF!**

Admittance to the Handicapped parking areas is in strict accordance to Pennsylvania State Law. ID Required.
