- Trial site will not be available to exhibitors the day before the trial.
- Lunch will be available on site for a small donation. Fast food is available within 2 miles.
- There will be **no smoking** in the building. Please dispose of trash in the proper manner.
- Training mirrors will be covered during the trial.
- All Obedience and Rally classes will be run in jump-height order. Saturday: Small-Tall Sunday: Tall – Small
- Limited handicapped parking will be available on the CTA lot. Additional parking: A parking map is included. Camper hook-ups not available. Free admission/Free parking.
- The judge is not required to wait for dogs. Each handler is responsible for being ready at ringside when required and without being called.



At light at Old Baltimore Pike, turn right. * Follow Old Baltimore Pike to Distribution Road and turn right at Shepherds Electric Company. 6822/6826 Distribution Drive is on right past after a curve to the left.
