<u>From the West:</u> From Leesburg, follow US 15 North, immediately after crossing the Potomac River Bridge, turn right onto Route 28 in Point of Rocks. Turn Right on Rock Hall Rd., just after crossing the railroad tracks. Turn left into the parking lot.
