## Notice to Exhibitors

- Transfers will be allowed for both the Obedience and Rally trials. The request for a transfer must be in writing and presented to the trial secretary at least 30 minutes prior to the start of the trial.
- Exhibitors and handlers will be responsible for clean conditions in and around their crating area. Matting is required to be placed under all crates and chairs to protect the floors.
- The judge is not required to wait for dogs. It is the responsibility of the owner/handler to have the dog at ringside when required and without being called. All dogs present must be held on a leash, or confined to a crate except when being judged.
- Dogs shall not be allowed to "potty" on the buildings or steps. Please use potty area at the end of the parking lot. Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Show Committee deems the exhibitor to be in violation of this requirement.
- There is no space for un-entered dogs.

## Directions

**From the Baltimore Beltway (I-695):** Take exit 17 West (Security Boulevard). At the traffic light opposite the mall entrance, turn right. Follow about 1/2 mile, turn left into the parking lot between 1718 and 1720 Belmont Avenue (after passing the MD State Police facility). Oriole facilities are on the left side of the driveway.

\*\* If using GPS/On-Star, please enter the ENTIRE address, not just 1718 Belmont Avenue. Not entering the entire address may cause you to end up in East Baltimore somewhere on Eastern Avenue.

\*\* Please observe parking restrictions and park only on Oriole's side of the parking lot. \*\*

Turn right out of the parking lot onto Belmont Avenue towards Grove Avenue. Turn left on Security Blvd. Merge onto I-695 South towards Glen Burnie. Take exit 13 for Frederick Rd/MD-144 towards Catonsville. Turn right onto MD-144. Turn left onto Mellor Avenue. Clinic is on the right. 4.4 miles, 8 minutes.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

- A 15-minute Obedience Novice A walk-through (for handlers without their dogs) will take place prior to the start of the class.
