Notice to Exhibitors

- All judging will be indoors.
- Transfers will be permitted in accordance with Obedience Regulations, Chapter 1, Section 16. The request for a transfer must be in writing and presented to the Trial Secretary at least 30 minutes prior to the start of the trial.
- Obedience classes will run in jump height order from "Tall-Small."
- Food is not available at the show site, no food vendors. Feel free to bring your own refreshments.
- **Crating:** Set-up will not be available on Friday. The building will open Saturday at 7:00 AM. Crating space is limited. Unentered dogs may be asked to leave. Please provide your own chairs and crates.
- **Parking space is limited.**
- Free admission / Free parking.
- **REFUND POLICY:**
Bitches in season are not permitted to compete in obedience trials. The club will refund all but \$10.00 of the entry fee for bitches in season that are unable to compete for that reason. Refund requests must be accompanied by a dated, signed letter on official business letterhead from your veterinarian stating the reason that your dog cannot compete. The Trial Secretary must be notified no later than one half hour prior to the start of the first class in the trial. E-mails, phone calls and non-letterhead notes will not be considered.
- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Show Committee deems the exhibitor to be in violation of this requirement. Crating space is limited. No ex-pens. Unentered dogs may be asked to leave. No dogs under 4 months of age on show grounds. There will be no smoking in the building. Please dispose of all trash in the proper manner.
- The judge is not required to wait for dogs. It is the responsibility of the owner/handler to have the dog at ringside when required and without being called. All dogs present must be held on a leash, or confined to a crate except when being judged.
- Exhibitors should follow their veterinarians recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The host club, Clantyre Show Secretary Services and its agents, employees, etc. will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.
- A limited number of catalogs will be available for sale at the show site for \$5.00.

Head west on Hornerstown-Arneytown Rd. toward Chesterfield Arneytown Rd.
Turn Right onto Chesterfield Arneytown Rd. Turn Right onto Province Line Rd.
Turn Right onto Polhemustown Rd. Turn Left Onto Ellisdale Rd.
Continue on S. Main St. Drive to Robbinsville Allentown Rd. in Robbinsville
Turn Right onto S. Main Street. Turn Left onto Church Street.
Continue onto Robbinsville Allentown Rd. Destination will be on the left.

Most GPS devices will get you there, make sure you see the flag on the driveway.

Arneytown Hornerstown Road is closed due to bridge construction. To reach Up Front Dog Training Center using Province Line Road, follow posted detours.

From NJ Turnpike exit 7A: Take I-195 East to Route 526. Make a Right on Route 526 to Main Street. Make a Right on Main St. to Route 539. Make a Left on Route 539 to Arneytown-Hornerstown Road. Make a Right on Arneytown-Hornerstown Road.

From NJ Turnpike exit 7: Take Route 206 North to Route 528 (Crosswicks Road). Make a Right on Route 528; travel approximately 6 miles, Pass through 1 roundabout. and stay straight DO NOT TURN RIGHT . Stay straight to go onto Arneytown Chesterfield Rd/County Hwy-664, (Road is now Route 664). Follow Route 664; it will turn right; On the corner you note a house with windmills. Continue to follow County Hwy-664 for approximately 2 miles. Turn left onto Arneytown Hornerstown Rd. Go approximately 0.49 mile on your left. A blue flag will be in front with the name Upfront Dog Center.

From Freehold: Start out going southwest on W Main St/County Hwy-537 toward Throckmorton St/ County Hwy-522. Continue to follow County Hwy-537. Follow Route 537 West. Turn Right on Route 539. Turn Left on Arneytown-Hornerstown Rd. Go approximately 0.49 mile on your left. A blue flag will be in front with the name Upfront Dog Center

From Mount Holly: Follow Route 537 East. Turn Left on Route 539. Turn Left on Arneytown-Hornerstown Road. A blue flag will be in front with the name Upfront Dog Center.
