## NOTICE TO EXHIBITORS

- ❖ All judging will be held indoors, on mats over concrete, with ring gating surrounding each ring. The obedience/rally area of the building has no heating or air-conditioning, but is well ventilated.
- ❖ **Crating:** The building will be open to set up crates for both trials starting at 7:00 a.m. on Wednesday, September 30. **No ex-pens** or grooming tables allowed inside the building.
- ❖ No dogs under six (6) months of age on show grounds.
- ❖ All dogs present must be on leash or confined to their crates except when being judged.
- ❖ **NO Flexi-Leads in the building.**
- ❖ **Food** is available on site.
- ❖ There will be **no smoking** in the building. Please dispose of **trash** in the proper manner.
- ❖ All persons are responsible for picking up after their dogs. Anyone not picking up after their dog will be asked to leave the show grounds. **NO EXCEPTIONS!**
- ❖ Free admission/Free parking. All Fire Lanes must be kept clear at all times. Vehicles left in Fire Lanes will be towed at the owner's expense.
- ❖ **The judge is not required to wait for dogs.** Each handler is responsible for being ready at ringside when required and without being called.
- ❖ **Conflicts!!** We will try our best to accommodate agility conflicts, although we offer no guarantee that we can resolve them all. **You can help by notifying the Obedience staff as soon as possible regarding potential conflicts.**
- ❖ Bitches in season are not permitted to compete in Obedience/Rally trials. The Club will refund the entry fees for bitches unable to compete for that reason upon presentation of a signed note (on official business letterhead) from a veterinarian stating that the bitch is in season. The note must be presented to the Trial Secretary by the end of the trial on Wednesday, September 30.
- ❖ **Obedience move-ups** will be permitted in accordance with Obedience Regulations, Chapter 1, Section 16. The request for a move-up must be in writing and presented to the trial secretary at least 30 minutes prior to the start of the trial.
- ❖ **Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.**

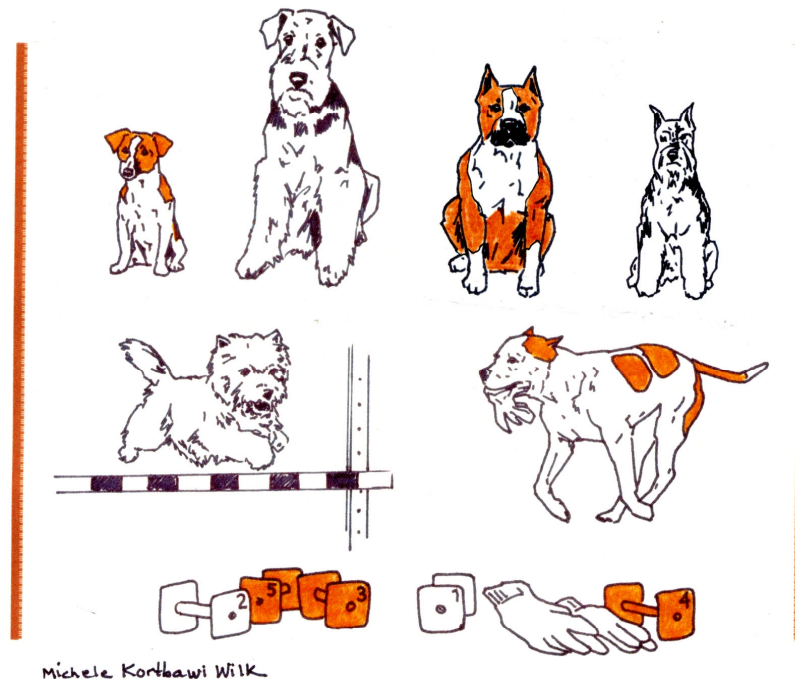
