Important "Covid-19" Trial Info



- **MOST IMPORTANT: If you are exhibiting signs of illness, have tested positive or have been otherwise told to self-quarantine due to known Covid-19 exposure, please stay home.**
- Crating will be allowed inside the building. Crates may not be placed in the building more than 1/2 hour before your scheduled time (if space permits.) Note that afternoon times listed are the *earliest* time the class may start, so check with a club member to make sure it's OK to set up. Crates must be removed when you are done showing. Working from your vehicles is encouraged. (Exception: Volunteers may crate their entered dogs all day.)
- Spectators will not be allowed in the building. Absolutely NO unentered dogs in the building, but they may be in the parking lot.
- Traffic flow in and out of the building will be clearly marked.
- Parking: Exhibitors may park all the way around the building. There is one business open on Friday and one on Sunday. Their parking spaces will be marked as reserved. RV Parking is not available.
- Masks: If unvaccinated, masks will be required when in the building, including in the ring while working your dog. Masks will not be required in the building for those fully vaccinated. ***As a courtesy, if the judge is wearing a mask, please plan on wearing a mask in the ring.***
- Social Distancing: Please continue to practice at least 4' social distancing while in the building.
- Paper course maps will not be available. Course maps will be displayed in several places. Come prepared to photograph the map(s) for your personal use.
- Food will not be available onsite. Plan on bringing your own lunch, water, drinks, ice, etc.
- Briefings/walkthroughs: Expect distance briefings, smaller walkthroughs.
- Ribbons may be self-serve.
- Exhibitors are expected to follow state, local government, event and facility guidelines.

Notice to Exhibitors

- All judging will be indoors.
- Transfers will be permitted in accordance with Obedience Regulations, Chapter 1, Section 16 and Rally Regulations, Chapter 1, Section 15. The request for a transfer must be in writing and presented to the Trial Secretary at least 30 minutes prior to the start of the trial.
- The judge is not required to wait for dogs. It is the responsibility of the owner/handler to have the dog at ringside when required and without being called. All dogs present must be held on a leash, or confined to a crate except when being judged.
- **REFUND POLICY:**
Bitches in season are not permitted to compete in obedience trials. The club will refund all but \$5.00 of the entry fee for bitches in season that are unable to compete for that reason. Refund requests must be accompanied by a dated, signed letter on official business letterhead from your veterinarian stating the reason that your dog cannot compete. The Trial Secretary must be notified no later than one half hour prior to the start of the first class in the trial. E-mails, phone calls and non-letterhead notes will not be considered.
- Exhibitors should follow their veterinarians recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The host club, Clantyre Show Secretary Services and its agents, employees, etc. will assume no responsibility for any loss, damage, illness or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.
- **Waiver of Rights – Animals in Distress: Talbot Kennel Club Inc.** reserves the right to remove an animal in distress from a parked vehicle or crate, and all persons attending these dog shows hereby waive any claim for damages against the club for such removal.

This Compliance Agreement and Waiver and Release Form must be agreed to and signed by anyone who will be entering the Talbot Kennel Club Training Center Building including instructors, all those attending classes and any others persons at or in the facility. A copy of this Compliance Agreement and Waiver and Release form will be kept on file.

I _____pledge to promote my own safety as well as that of others while using the Talbot Kennel Club Training Center Building.

If I am entering the TKC Training Center or attending any TKC training or event at any location, at any time, for any reason, I will be responsible for my own health and well-being.

To the best of my knowledge, I do not have COVID-19; I have not been exposed to the virus within the last three weeks, and I have had no symptoms (fever, cough, etc.) for 14 days, or more.

Should I feel ill, or if I find I have become exposed to the virus, I agree to contact the class instructor and will not attend class or return to class until I have determined I am no longer affected by COVID-19, or I have been symptom-free for at least three weeks or more.

I agree to bring my own mask and wear it while inside the training center building, if required.

I agree to practice safe social distancing while inside or outside the Talbot Kennel Club training center.

I agree to follow guidelines regarding frequent hand washing/sanitizing while using the training center facilities.

I understand that if I am found to not be in compliance with the requirements as stated herewith, and I refuse to comply, I will be asked to leave the training center building.

I agree Talbot Kennel Club, its Board of Directors, instructors, members and Clantyre Show Secretary Services will not be held liable for any present or future COVID-19 infection incurred at any time by myself or any person, in attendance or not in attendance, before, during or after use of the Talbot Kennel Club Training Cener Building, for any purpose.
